‘He stood firm in what he believed’

Dr. Arthur T. Carter, former N’hampton supervisor, recalled as the conscience of a community

Dr. Arthur T. Carter, the former two-term member of the Northampton County Board of Supervisors who walked away from his Nassawadox obstetrics and gynecology practice to dedicate himself fully to creating economic and housing opportunities on the Eastern Shore, died

Wednesday, April 5, after a brief illness.

Carter, who had largely stepped back from crowds and the community spotlight to mitigate impacts on his immune system after receiving a heart transplant 21 years ago, was 76 years old.

Carter became a local household name several times over — first as a respected physician, then as an elected official, and then as the president of a grant-funded

corporation that helped provide, among other initiatives, small business loans for would-be entrepreneurs with a dream but little else.

But it was his force of character, intellectual nimbleness, and rich personal background — his grandfather was a Northampton County slave who was elected to the House of Delegates after

Schools seek \$918K in new funding

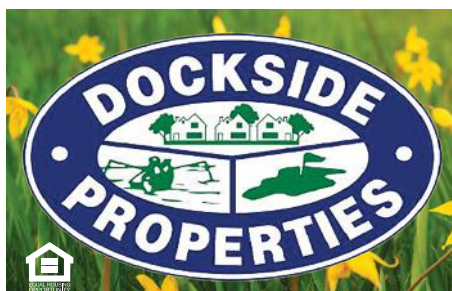

The Northampton School Board budget presented to county supervisors Tuesday night had a shortfall of \$918,000 even after expenses were reduced to the necessities, according to school officials.

Superintendent Lisa Martin said, “Our plan this year is very simple: We are just trying to keep the lights on, the buses running, offer a regionally competitive pay increase for all staff, ... offset inflation, and provide safety and security for our children and for our staff and for our families.”

A major contributor to the shortfall was the required local

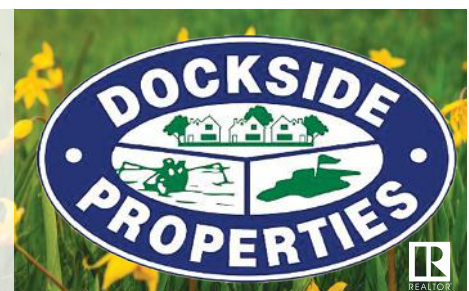

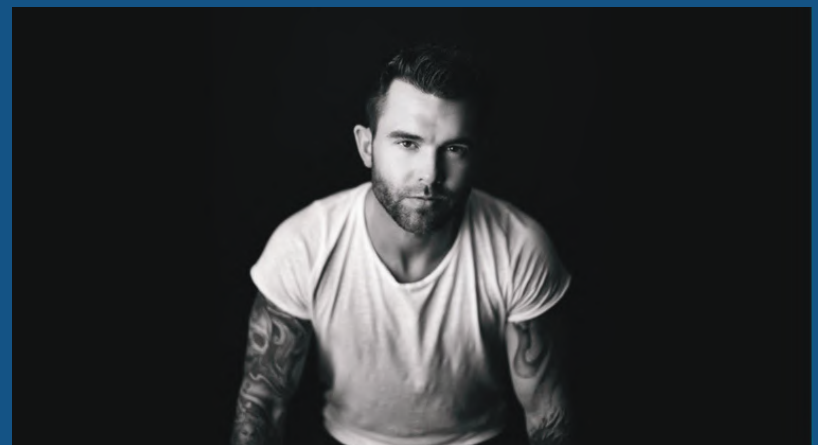

INTRODUCTION (This notice will not be mailed.)

This Annual Drinking Water Quality Report for calendar year 2022 is designed to inform you about your drinking water quality. Our goal is to provide you with a safe and dependable supply of drinking water, and we want you to understand the efforts we make to protect your water supply. The quality of your drinking water must meet state and federal requirements administered by the Virginia Department of Health (VDH).

GENERAL INFORMATION

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or human activity.

Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife;
- Inorganic contaminants, such as salts and metals, which can be naturally occurring or result from urban storm-water runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming;
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm-water runoff, and residential uses;
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, and septic system;
- Radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities

Drinking water, including bottled drinking water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. More information can be obtained by calling the Environmental Protection Agency's Safe Drinking Water Hotline (800-426-4791).

In order to ensure that tap water is safe to drink, the EPA prescribes regulations which limit the concentrations of certain contaminants in water provided by public water systems. Food and Drug Administration regulations establish limits for contaminants in bottled water, which must provide the same protection for public health.

Maximum Contaminant Levels (MCLs) are set at very stringent levels by the U.S. Environmental Protection Agency. In developing the standards EPA assumes that the average adult drinks 2 liters of water each day throughout a 70-year lifespan. The EPA generally sets MCLs at levels that will result in no adverse health effects for some contaminants or a one-in-ten-thousand to one-in-a-million chance of having the described health effect for other contaminants.

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers.

EPA/CDC guidelines on appropriate means to lessen the risk of infection by cryptosporidium and other microbiological contaminants are available from the Safe Drinking Water Hotline (800-426-4791).

SOURCE OF YOUR DRINKING WATER AND TREATMENT

The Town of Chincoteague water system receives its water from wells located on the Mainland. These wells have been determined to be groundwater and not under the influence of surface water. Your water is treated with chlorine to ensure water quality.

The Virginia Department of Health conducted a Source Water Assessment of the Waterworks in 2014. The wells were determined to be of low susceptibility to contamination using the criteria developed by the state in its approved Source Water Assessment Program. The assessment report consists of maps showing the Source Water Assessment area, an inventory of known Land Use Activities and Potential Conduits to Groundwater utilized at Land Use Activity sites in Zone 1, Susceptibility Explanation Chart and Definitions of Key terms. The report is available by contacting the waterworks system owner/operator at the phone or address provided above.

PER-AND POLY-FLUOROALKYL SUBSTANCES (PFAS)

PFAS are manmade compounds used extensively in a wide variety of consumer products and are also components of firefighting foams. NASA conducted training with a commonly-used firefighting foam containing PFAS chemicals at a firefighter training area located on the Wallops Main Base, starting in the 1980's. This resulted in PFAS contamination of shallow groundwater in associated areas. NASA, in collaboration with local, state, and federal agencies, is monitoring the facility's groundwater and drinking water wells, along with the Town of Chincoteague's drinking water wells--located on NASA property.

In 2016, the EPA issued updated Lifetime Health Advisory (LHA) level guidelines of 70 parts per trillion for two PFAS compounds, PFOS and PFOA, in drinking water. NASA Wallops has been sampling the drinking water for these compounds since 2017.

NASA will continue to monitor drinking water supplies for the Wallops Flight Facility and the Town of Chincoteague. The agency will continue to share all drinking water sampling results with local officials, EPA, Virginia Department of Environmental Quality (VDEQ) and the Virginia Department of Health (VDH), and will provide information to the public.

DEFINITIONS

In this report you will find many terms and abbreviations you might not be familiar with. The following definitions are provided to help you better understand these terms:

- Non-detects (ND) – Lab analysis indicates that the contaminant is not present.
- Parts per million (ppm) or milligrams per liter (mg/l) – One part per million corresponds to one minute in 2 years, or a single penny in \$10,000.
- Parts per billion (ppb) or micrograms per liter (µg/l) – One part per billion corresponds to one minute in 2,000 years, or a single penny in \$10,000,000.
- Parts per trillion (ppt) or nanograms per liter (ng/l) – One ounce out of 31,250 tons.
- Action Level (AL) – The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.
- Maximum Contaminant Level (MCL) – The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
- Maximum Contaminant Level Goal (MCLG) – The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
- Maximum Residual Disinfectant Level (MRDL) – The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.
- Maximum Residual Disinfectant Level Goal (MRDLG) – The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.
- Treatment Technique (TT) – A required process intended to reduce the level of a contaminant in drinking water.
- Level 1 Assessment – An evaluation to identify the possible presence of sanitary defects, defects in distribution system coliform monitoring practices, and (when possible) the likely reason that the system triggered the assessment.
- Sanitary Defect – A defect that could provide a pathway of entry for microbial contamination into the distribution system or that is indicative of a failure or imminent failure in a barrier that is already in place.

WATER QUALITY RESULTS

Contaminants in your drinking water are routinely monitored according to Federal and State regulations. The EPA requires that Table I reflect monitoring results for the period of January 1st, 2017 through December 31st, 2021. The

state allows us to monitor for some contaminants less than once per year because the concentrations of these contaminants do not change frequently. Some of our data, though accurate, may be more than one year old. Only the most recent sample results from the prescribed period are reported. The table lists only those contaminants that had some level of detection. Many other contaminants have been analyzed but were not present or were below the detection limits of the lab equipment.

A note about arsenic in drinking water: While your drinking water meets EPA's standard for arsenic, it does contain low levels of arsenic. EPA's standard balances the current understanding of arsenic's possible health effects of low levels of arsenic, which is a mineral known to cause cancer in humans at high concentrations and linked to other health effects such as skin damage and circulatory problems.

Country music band Sawyer Brown will headline the second annual ESVA Chamber Fest, which will happen Saturday, Sept. 9, on the grounds of Eastern Shore Auto Body, on Fairgrounds Road, near Tasley.

Robert Sabbatini, executive director of the Eastern Shore of Virginia Chamber of Commerce, announced the festival lineup Wednesday during the "Chamber Chat" radio show on WESR.

Opening acts include classic rock band Jefferson Starship and local favorite Irie Tree Band.

Listeners Terran Campbell and Joan Murden called in and correctly answered trivia questions to reveal the names of the two main bands and win free tickets to the festival.

Tickets go on sale May 1 and will be available only through chamber members. Tickets cost \$75 each, including entry into the event and all-you-can-eat food items.

Sawyer Brown has released 20 studio albums and charted more than 50 times on the Billboard Hot Country Songs charts, including three number one hits: "Step That Step" (1985), "Some Girls Do" (1992), and "Thank God for You" (1993).

The group was named Vocal Group of the Year in 1996 by the Academy of Country Music, among other honors. Band members are Shayne Hill on lead guitar, Joe

Smyth on percussion, Gregg Hubbard on keyboard, and lead vocalist Mark Miller.

Jefferson Starship was formed in 1974 by musicians including former members of Jefferson Airplane.

The band was one of the most successful arena rock groups of the 1970s and 1980s, earning three platinum and eight gold records, as well as numerous Top 40 singles.

A revival of the group, led by Paul Kantner, started in 1992 and has continued under the name Jefferson Starship after Kantner's death in 2016.

Current band members are David Freiberg, Donny Baldwin, Cathy Richardson, Chris Smith, and Jude Gold.

Last fall's inaugural Chamber Fest featured performances by Southern rock band Molly Hatchet, Lana Scott, and Irie Tree Band.

In addition to the music, the inaugural festival included "great food, great fun, great networking for the businesses," Sabbatini said, adding, "I have no doubt that we will repeat and go above and beyond this year when folks hear these two bands."

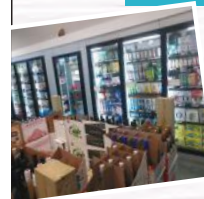

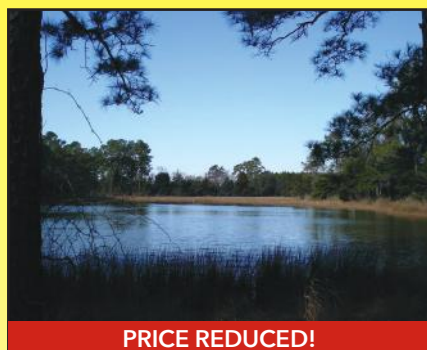

Notorious Cemetery Road to be upgraded by end of '24

Northampton County's top priority under its Virginia Department of Transportation Secondary Six-Year Plan remains the repair of Cemetery Road, aka Route 602.

"I know that you take your life in your hands driving on Cemetery Road," said Supervisor Betsy Mapp on Tuesday.

"It's a very rough road," agreed Chairman John Coker.

Cemetery Road, which approaches the Belle Haven Cemetery from the south, has been in severe disrepair for years and is currently the only project in Northampton's secondary road plan for 2024 through 2029.

Chris Isdell, VDOT Accomac residency administrator, noted that Northampton is working on one secondary road project at a time and will need to identify its next project within

the next year.

The Cemetery Road repairs are expected to be complete by November 2024.

The project will cost about \$1.4 million and was fully funded with the help of state legislators in Richmond, Isdell said.

Northampton receives around \$33,000 a year in program funding, or about \$200,000 every six years, which is "not a lot of money when you're talking transportation costs," Isdell said.

Coker calculated that at \$33,000 a year and without supplemental funding, it would take 40 years to pay for another project like Cemetery Road.

Isdell noted that reduced funding for VDOT Secondary Six-Year Plan projects is a statewide issue that must be addressed.

He added that population is one factor in determining how much money a locality receives, which puts the Eastern Shore at a disadvantage.

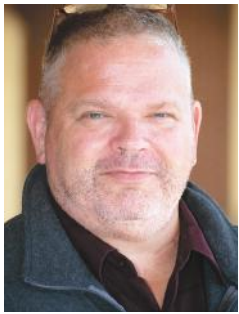

Which clam fritter recipe is perfect? All of them, it seems

There are a lot of Eastern Shore clam fritter recipes in circulation. So I figured finding the perfect recipe for the flavorful fritters would be easy.

But each of the recipes is essentially regarded as the perfect rendition. And the more I read, the more confused I became.

They can't all be perfect, can they?

There was a new-to-the-Shore guest due for dinner at our home and I wanted to prepare a relatively easy and seasonally appropriate Eastern Shore meal.

When I cook, I always prepare something I like to eat. That way, if nobody else particularly cares for it, I can help myself to the extra

servings.

One of my favorite all-time meals is the Eastern Shore ham-and-clam dinner. It's a staple of delicious fundraiser suppers — a couple of slices of high-quality ham, a couple of salty clam fritters, and a vegetable of some sort.

I'd given up on making my own clam fritters many years ago after a batch I concocted fell well short of my personal expectations.

I was trying for fireman's carnival-quality clam fritters. I ended up with clam fritters that looked like they had been prepared by a cranky cook at 3 a.m. at a truck stop in some landlocked state, far from the coastal clam beds.

I decided to stick with easier stuff, like frying oysters and smoking pork shoulders.

But I have since eaten enough clam fritters that I wanted to give the process another try. Plus, we already bought the ham. So my clam fritter research began.

I was surprised to find that everyone claims to make perfect Eastern Shore clam fritters in a slightly different way.

Some cook them in oil in a cast-iron skillet. Others cook them on a griddle with just a splash of oil.

Some chop the clams beforehand. Others grind them in a hand-crank meat grinder.

Some warn against shredding the clams in a food processor. Others say a food processor is fine as long as the blade and setting do not disintegrate the meat.

Some use pancake mix. Others only use flour.

One of my favorite finds was a YouTube video from two years ago by the Museum of Chincoteague Island.

Cindy Faith, the museum's executive director, interviewed Andy Linton, who gave a demonstration on making carnival-style clam fritters. It is an interesting and informative piece.

It was full of helpful hints — like the importance of oiling the spoon before dipping out the dollops of batter into the oil.

Another great resource was the 2019 book, "A South You Never Ate: Savoring Flavors and Stories from the Eastern Shore of Virginia," by Bernard Herman.

I loved the book when I first read it. Now, I essentially snack on the book, flipping through it to rediscover great morsels.

The author did a number of interviews with local experts on preparing clam fritters. It is a delightful read.

Then I found a simple but lauded recipe on a website called Jim's Galley Blog. It was from a decade ago and featured a long-closed Northampton County eatery.

It used pancake mix, clams, and salt and pepper. I threw in some corn starch so the fritter edges might be crispier. I heated a pan of oil and liked the results — and so did everyone else that night at dinner.

Best of all, I had plenty left. We warmed them in the oven the next day and they seemed even better.

I picked them up with my hands and ate them while leaning over the kitchen sink, which is how I almost always eat leftovers.

They might just be the perfect recipe for clam fritters.

But I've found just about all clam fritter recipes are perfect, more or less.

The long and delicious history of oysters on the Eastern Shore

The Eastern Shore area had oysters before it had the Chesapeake Bay. About 18,000 years ago, the Susquehanna

River flowed through valleys (now covered by the bay) and emptied into the Atlantic Ocean. Oysters flourished along tidal areas in rivers and streams running through that “empty” valley.

At the end of the last ice age, as polar caps and glaciers melted back, ocean levels rose and the Susquehanna valleys flooded to form Chesapeake Bay. Today, half of the bay’s water comes from the ocean, the other half from streams and rivers that dump about

51 billion gallons of water into the bay each day.

Oysters thrive in this mix of salt and fresh water and would have given a thumbs up (if they had thumbs) to the development of the Chesapeake Bay estuary, where they once grew in an abundance that’s hard to imagine.

According to the University of Maryland, in the late 1800s more than 15 million bushels of oysters were being taken each year from just the Maryland portion of the bay.

Now, the oyster population in that part of the bay is, according to the university, only about 0.3% of what it was in the 1800s.

Last year’s Maryland oyster harvest was considered good at half a million bushels.

Oysters collect in both horizontal and vertical reefs but, given their druthers, they seem to prefer vertical reefs that lift them out of the bottom muck, provide protection from predation, and give

the bivalves the good water flow they need for nutrients.

When Europeans first began sailing in the Chesapeake Bay, they would crash into vertical oyster reefs that occasionally rose to the top of the water.

Harvesting oysters from these vertical reefs was easy peasy: Row or wade to a reef, pick off oysters with your hands or a rake, and call it a day. Those boating-hazard vertical oyster reefs are largely gone from the bay.

For at least 3,000 years, native populations around the Chesapeake Bay harvested oysters and left the shells in massive deposits called middens.

Evidence from those middens show that Native Americans likely didn’t open the shells to retrieve the meat. Instead, whole oysters were put on fires that caused the shells to open and cooked the oysters.

Crassostrea virginica, the native Chesapeake Bay oyster, also known as the eastern or Atlantic or Virgin-

ia oyster, is, of course, the best in the world. But more than 200 other species of oysters are found along the coastlines of every continent except Antarctica.

Americans in the 1800s were oyster crazy, slurping down a national average of 660 oysters per person per year, according to the International Wine and Food Society. Today, the average is three oysters per person per year.

Even if you hate oysters (in which case you may vacate the Shore at your convenience), you should root for their restoration.

Each adult oyster filters 50 gallons of bay water daily, including removing or neutralizing sediment and nitrogen that pollute the bay.

Once upon a time, bay oysters could filter the entire 19 trillion gallons of bay water in a week.

Today, our remaining hard-working oysters require more than a year to filter all the water in the bay.

match for state funding for at-risk students, those at risk of failing due to poverty and other factors.

The state takes an “all or nothing” approach to at-risk funding. Northampton must accept the entire at-risk funding package, committing to the local match, or it will lose \$1.4 million, Martin said.

Included in the school budget is an additional \$524,000 to fund at-risk positions including eight more instructional assistants — four at the elementary schools and four at the middle school — and a second behavioral specialist.

Some additional school staff are required by the Virginia Department of Education’s Standards of Quality.

For example, VDOE has changed the ratio of students to specialized student support staff, such as social workers, school psychologists, and nurses, from 4-1 to 3-1.

Oliver Bennett, vice chairman of Northampton’s board of supervisors, noted the county is planning to spend \$50 million to \$70 million on renovations and new construction at its high school, and he has been asking for a plan to better maintain Northampton’s school facilities but has yet to receive one.

Bennett, himself a teacher in the county, also wants the school division to update its dress code and address student behavior, including defiance, profanity, and the use of electronic devices.

He added that the county contributes around \$1 million more for public education than the state requires.

Martin, who has been superintendent for approximately 75 days, said issues like the student code of conduct and dress code are on her “to-do list.”

Bennett indicated that he may not vote for the \$918,000 in additional local funding if the school division does not address his concerns.

“No disrespect, but your school board has heard this for the last two or three years,” he said. “It tells me, ‘Yeah, you said it, and so what?’ My ‘so what’ is looking at other means of

getting your attention.”

The school division is requesting nearly \$10.5 million in local funding this year, compared to about \$9.6 million last year.

Supervisor Betsy Mapp pointed out that’s about \$7,700 for each of Northampton’s approximately 1,300 public school students.

Northampton supervisors also wanted to know why the school operating budget includes an additional \$25,000 for electricity and about \$35,000 more for heating fuel when both elementary schools have brand-new hydrothermal heating and cooling systems intended to save money.

Supervisors asked for a study to determine the actual savings, if any, generated by the operation of the new HVAC systems.

The budget also includes 7% teacher raises as recommended by the state Senate.

The 7% will be reached by giving every teacher a raise of 5.75% plus a step raise (a step on the salary scale, equaling one year of experience) of 1.25% to 1.5%.

Martin emphasized the need to make Northampton teacher salaries competitive. Currently, the school division ranks last in the region for salaries for teachers with more than five years of experience, she said.

The budget includes a \$20 additional monthly contribution to the cost of health insurance for eligible employees.

The school division also plans to increase its minimum wage for non-salaried employees such as cafeteria workers and custodians.

The Northampton schools’ minimum wage is expected to rise to \$13 an hour in July 2023, \$14 an hour in July 2024, and \$15 an hour in July 2025.

The school division would outpace the state on minimum wage hikes. Virginia’s minimum wage will increase from \$12 an hour to \$13.50 an hour in January 2025 and will not reach \$15 an hour until January 2027.

Bennett said of Northampton schools’ hourly employees, “My concern is that they be treated the best that they possibly can so they can survive with their families.”

\$40M draft budget includes raises, benefits, and new \$359K bulldozer

Northampton County's proposed fiscal year 2024 budget is balanced and includes general fund expenditures of more than \$40 million, Director of Finance John Chandler said Tuesday night.

That includes about \$645,000 to give all county employees a 7% cost-of-living raise, which was recommended by both houses of Virginia's General Assembly.

The budget also includes about \$115,000 for county employee benefits.

As of January, Northampton's real estate tax revenue was expected to rise nearly \$514,000 in the upcoming fiscal year.

Since then, Northampton's commissioner of revenue has determined the county is home to new construction valued at \$45 million, and the increase in real estate tax revenue will be about \$150,000 higher than previously expected.

However, the assessed value of vehicles is expected to drop 20% or more,

meaning the county will receive about \$525,000 less in personal property tax revenue.

The personal property tax revenue estimate would have taken an even bigger hit if the personal property tax rate hadn't been raised.

Last year, the personal property tax rate was reduced to \$3.60 per \$100 of assessed value to help offset the increase in vehicle assessments, which had risen about 25%.

This year, the personal property tax rate returns to \$3.90 per \$100 of assessed value, and vehicle assessments could drop as much as 25%.

The good news for taxpayers is that their personal property tax bills should be lower in the upcoming fiscal year.

“The fix is actually quick,” Chandler said.

He called personal property taxes “one of those yo-yos that we don’t like in the world of budgeting.”

Members of the Government Finance Officers Association have observed that vehicle assessments in other Virginia localities have decreased dramatically, Chandler said.

They offered no reason why this occurred, but Chandler later noted that last year there was high demand for used cars, which could have impacted their assessed value.

One highlight of the budget is the new method of distributing Northampton’s cigarette tax revenue.

The county’s cigarette tax is 40 cents a pack and has brought in an average of \$33,000 a month over the last eight months, according to Chandler’s presentation.

The cigarette tax could generate annual revenue between \$350,000 and \$400,000.

About 50% of the annual cigarette tax revenue will support emergency services. Each of Northampton’s five fire departments will receive \$35,000, a total of \$175,000.

Previously, each fire department was set to receive just \$5,000.

Northampton’s incorporated towns will receive 25% of the cigarette tax revenue based on population, or approximately \$37,000 for Exmore, \$30,000 for Cape Charles, \$13,000 for Nassawadox, and \$12,000 for Cheriton. Eastville is excluded because it imposes its own cigarette tax.

The remaining 25% of the cigarette tax revenue, or about \$91,000, will support community development projects.

Big-ticket items in the budget include \$627,000 for the final phase of roof construction at the county’s future community center, which will be housed in the former Northampton Middle School building in Machipongo.

Nearly \$359,000 will be spent on a bulldozer, completing the replacement of all the heavy equipment at Northampton’s waste transfer station, which also includes an excavator and a wheel loader.

Another \$300,000 will be spent to expand the Bayview convenience center, bringing the total cost of that project to \$700,000.

Chairman John Coker said the cost to construct what is essentially a strip of asphalt is “unbelievable.”

County Administrator Charlie Kolakowski said, “This is the price of ... construction and complying with the requirements of the state,” such as a drain field and water retention pond.

Chandler said, “a \$10,000 conversation about the budget ... now becomes \$100,000 every time you turn around anymore. The numbers are certainly big.”

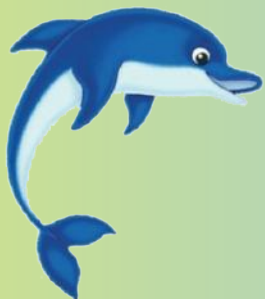

the Civil War — that gave Carter unique community standing.

“He stood firm in what he believed, and that was to help people,” said Jane Cabarrus, the president of the Northampton County Chapter NAACP.

Cabarrus acknowledged, however, that Carter’s advocacy wasn’t universally praised.

“Some saw him as being too forward and outspoken,” she said.

Carter’s election to the board of supervisors in 1992, less than a decade after moving his medical practice to the Eastern Shore from Hampton Roads, was as inspirational to some as it was unsettling to others.

The personal journey of the new leader ran counter to the social norms of a rural, agrarian southern county. Never before or since has an Eastern Shore elected official’s milieu so thoroughly defied convention.

Carter’s wife, an attorney and native of the Boston area, described herself as a “flaming feminist” who instilled a similar point of view in her husband. Theirs was a rare interracial marriage in the county.

Arthur Carter held a bachelor’s degree from highly selective Georgetown University and had no qualms about publicly debating other elected colleagues when he believed policies and thoughts weren’t fair to all.

Carter’s physical presence also conveyed a powerful aura. At a height of 6-foot-5 with a white beard that sometimes grew long, Carter was the focal point in every room he entered.

At Georgetown he was an acclaimed boxer, winning a Golden Gloves amateur title in a match covered in a Washington, D.C., newspaper.

Most rankling to some was that Carter, in the late 1960s, had joined the Republic of New Africa, a Black nationalist group, and in Detroit he became its liaison with the Black Panther Party.

During that time, Carter was the spokesman in Detroit for nine militant Black groups that threatened action against police to end alleged heavy-handed tactics.

Carter embraced the experience. Others were wary of his association with militant Black groups, even years later.

Carter caused a further stir when, as a county supervisor and leader of a group called the Virginia Eastern Shore Economic Empowerment and Housing Corporation, he gave up his medical practice to focus full time on alleviating poverty and creating opportunities.

Critics thought it was suspicious and the rumor mill whirled in high gear.

His widow said the move showed the depth of his conviction.

“Society is so geared toward making the most mon-

ey you can make,” she said. “They thought it was crazy giving up all that money and income.

“He liked practicing medicine but ... his priority was that there be social change.”

‘Make society better’

Carter was born in Franktown on June 26, 1946, to a family that similarly defied convention.

His grandfather, Peter Jacob Carter, was born near Eastville, fought for the Union in the Civil War, and represented Northampton County in the House of Delegates for eight years — the last Black man from the Eastern Shore to be elected to the General Assembly.

A state historical marker near Franktown details his life and work.

Carter’s father was a physician and his mother was a registered nurse with a master’s degree.

“His family was so amazing in their accomplishments,” Marsha Carter said. “They were all geared toward, whatever you did, you had a responsibility to make society better.”

When Carter was 2, his father took a job at a Veteran’s Administration hospital and the family moved to Alabama. Carter attended a Pennsylvania boarding school at age 13 and was a pre-medicine major at Georgetown, where he met his future wife.

He was a college senior; she was a junior who had transferred to the school. She asked him to dance at a social event.

“He could really dance so well,” she said. “I just wanted to dance with someone who knew how to dance.”

They married in 1970 and Carter returned to medical school at the University of Cincinnati. His internship and residency were completed at Eastern Virginia Medical School in Norfolk.

After practicing medicine in Hampton Roads, he returned to the community of his birth in 1983 when the Carters and their two daughters moved to the Eastern Shore.

“He wanted to come back to the Shore, to his roots, to make a difference,” said Cabarrus. “It was just in his blood.”

For most of a dozen years, ending in 2000, it seemed like Carter was everywhere at once — delivering babies, seeing patients, voting on county initiatives as an elected official, and working in community organizing.

When Citizens for a Better Eastern Shore began in the late 1980s, Carter was a vice president of the grassroots group.

He was one of the founders of a Northampton housing group whose 1989 study found 29% of the county’s homes had incomplete plumbing, 25% had structural problems, and 77% of the wells were contaminated with fecal bacteria.

Later, Carter and others founded an economic empowerment and housing group that now calls itself Credence Community Capital.

At the time, the group provided microloans to business startups and worked to improve and create housing stock.

However, it came under fire for backing a number of businesses that failed.

In addition, a shelter for women and children at a former U.S. Route 13 motel in Birdsnest, which the group opened to fanfare, closed after several years, with Carter admitting the initiative’s failure was due to his group’s lack of experience with such a project.

‘Human struggle’

Carter was a scholar of African American history and lecturer on the trans-Atlantic slave trade. He also became an advocate for all disadvantaged groups and a voice of racial reconciliation.

He was a member of Eastern Mennonite University’s chapter of Coming to the Table, a national initiative to heal racial wounds. The university is near Harrisonburg, Va.

“He so believed in the community and all people, in all groups, having a say — not just the privileged or rich,” his wife said.

She said Carter believed “each human being should be given the opportunities and allowed to rise up and develop their full potential.

“This was a human struggle, not just a Black struggle.”

After recovery from his heart transplant, Carter also was active in a choir called the Multi-Ethnic Eastern Shore Spirituals and Group Ensemble, which included almost 50 singers that performed songs composed by slaves during bondage.

Carter said the songs were codes to escape from slavery and to provide strength and inspiration.

He did not sing with the group, however.

“A frog knows not to croak while angels sing,” he once wrote in a letter to his older daughter.

One of Carter’s last acts of advocacy was three years ago when localities around the state began removing Confederate statues on public grounds.

Carter stood before the board of supervisors on which he once served and proposed a new plan — instead of removing the century-old Confederate soldier statue on Eastville’s courthouse green, he asked that the county add an African American Union soldier statue to the area.

The move would enhance historical understanding instead of erasing it.

“That would show the world that we have a better way,” Carter told supervisors in August 2020.

County leaders were unfazed. A year later, the Confederate statue was removed after a vote by the board of supervisors.

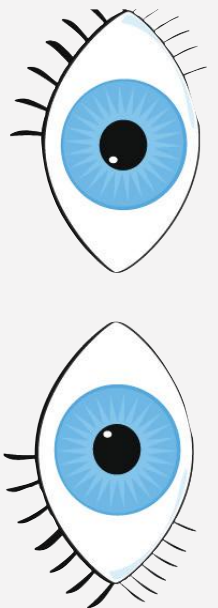
