‘We were just taking a walk’

2,500 SIGN PETITION SEEKING CHARGE AGAINST DRIVER WHOSE VEHICLE KILLED WOMAN

Accomack prosecutor says investigation continues, will be handled with ‘sensitivity and decorum’

Duane Lee Turner looked around for his girlfriend and her daughter in the moments after the vehicle struck them.

The 6-year-old child, who was riding a bicycle, was injured and lying nearby.

His girlfriend, 26-year-old Erika Cherrelle Bailey, had been knocked approximately 60 feet east on Nocks Landing Road during the Wednesday, April 12, incident.

She was killed on impact, police said. It was a sunny, warm afternoon, and still an hour from sunset.

“We were just taking a walk,” said Turner the morning of Monday, April 17, while sitting on the front step of his home.

Turner and the child were hospitalized after the crash. He had returned home and the child’s condition was improving, he said.

Flowers had been set on the road shoulder where the vehicle made impact. Another set of flowers was placed where Bailey died.

In the aftermath, a state police spokeswoman said the “investigation of the crash has taken much longer” because of the complexity of the situation, among other factors.

The spokeswoman said the Accomack County Commonwealth’s Attorney’s office will make the final determination on whether charges are to be brought against the driver.

However, an online petition on the website www.change.org that advocated bringing charges against the driver has drawn 2,500 signatures.

The driver, Jessica Greenley Waterfield, 36, of Atlantic, was headed east in a 2021 Honda Pilot sport utility vehicle with a 3-year-old passenger. Neither was injured, according to state police.

According to state police, neither

alcohol nor speed was a contributing factor in the crash.

Commonwealth’s Attorney Spencer Morgan acknowledged in a prepared statement “several members of the community have contacted my office” regarding the incident.

He also worked to explain the process amid community fervor in the wake of the crash.

Morgan said his office owes “a duty to all parties involved, and to the community, to ensure that the investigating agency, along with the courts, handle this matter with sensitivity and decorum in the pursuit of justice.”

Twice in the statement Morgan called the collision an “accident.”

Morgan did not give an indication in his statement of when the investigation would be complete.

“This office intends to carefully review all of the available evidence prior to making any decision,” he said.

The incident took place in a 40 mph zone, one-tenth of a mile from a

25 mph zone and about three-tenths of a mile from the Nocks Landing Road intersection with Atlantic Road, near the post office and Wolff’s Sandwich Shoppe.

The narrow road, which is lined with driveways, widens significantly as it approaches Atlantic Road.

“I don’t know how (the driver) didn’t see us on a straight road,” said Turner, who wept as he spoke of the crash.

Turner also contradicted state police reports that they were teaching the child how to ride a bicycle.

“She had known how to ride a while,” he said.

The crash happened about 15 feet from Turner’s driveway.

He said he had noticed the vehicle approaching from a distance.

“When you walk out in the road, you always look both ways,” he said.

Soon afterward, he said he warned the woman and child that the vehicle was approaching.

“There’s a car coming,” he said, before it hit them.



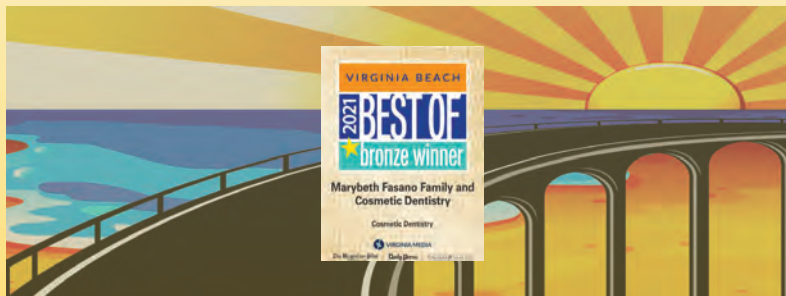

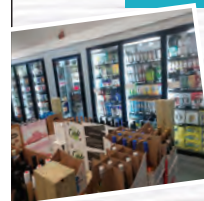

Aerospace Academy Lab School of the Eastern Shore

In cooperation with Accomack and Northampton School divisions, Eastern Shore Community College received a \$200,000 planning grant from the Virginia Department of Education to design the Aerospace Academy Lab School of the Eastern Shore. One of the first 13 awarded in the Commonwealth, Governor Glenn Youngkin recently made the announcement on the development of these innovative lab schools.

The Lab School will work with and complement the work of the Cal Ripken, Sr. Foundation (CRSF) in providing labs to 16 schools on the Eastern Shore including ESCC.

The Aerospace Academy Lab School of Eastern Shore (AALSES) will be developed with the help of established community partners, schools, and organizations to help underserved youth and families pursue STEM-based careers. The AALSES will create a continuum of STEM learning from Pre-K to high school and then transitioning to the college level, culminating in career opportunity and advancement in the aerospace industry.

In addition to coursework, students will have internship and apprenticeship opportunities to work in the aerospace industry using established corporate partnerships, such as NASA Wallops and Goddard, Virginia Space, and companies in the Wallops Contractors' Associations.

The Eastern Shore of Virginia is a natural hub for aerospace industry. Wallops Island, Virginia, is one of only four locations in the United States where rockets can be launched into orbit. It is home to NASA Wallops

Flight Facility (WFF), managed by NASA Goddard Space Flight Facility, Virginia Commercial Space Flight Authority (Virginia Space), and the Mid-Atlantic Regional Spaceport (MARS).

"The Aerospace Academy Lab School of the Eastern Shore is an opportunity to have a rising tide that will truly lift all boats," said ESCC President Jim Shaeffer. "I feel very lucky to have the opportunity to work with my colleagues at the school divisions and to have the expertise of the Cal Ripken Sr. Foundation in curriculum and lab school design."

The innovation of the AALSES program starts with working with our aerospace industry partners to identify skills and knowledge needed for our students to be successful employees. Content experts at the schools and community college as well as our curriculum partners at CRSF will work together to create an educational pathway where courses at the schools transfer seamlessly to the college and to the workplace.

Founded to honor the legacy and life of Cal Ripken, Sr., a longtime coach and mentor, CRSF prepares at-risk youth for life's challenges by teaching them critical life skills such as teamwork, communication, work ethic, and respect.

"Our STEM program will provide tools that will help students succeed and thrive. Through our work on STEM programs across the country, we know that hands-on learning helps kids become more curious. As a result, they become better problem solvers," said Steve Salem, President and CEO for the Cal Ripken, Sr. Foundation.

CRSF has already created 13 elementary and middle STEM Centers in Accomack and Northampton County schools which include trained teachers, educational STEM activities, a custom-designed STEM curriculum, and technology. This planning grant will allow the AALSES to install educational STEM resources, teacher training, and update, grade-level appropriate STEM curriculum to all divisions throughout both counties.

In addition, professional development and collaborative opportunities for teachers will help maximize the instructional effectiveness of the Cal Ripken Sr. Foundation STEM Centers. Students will increase their awareness of STEM-related careers in our area and work to break the cycle of generational poverty by widening the horizons of our young learners, allowing them to see a successful future for themselves without having to leave the Eastern Shore.

Initial meetings between CRSF, ESCC, and the school systems of Accomack and Northampton County have already begun. In addition, there will be work with NASA Wallops Flight Facility, Virginia Commercial Space Flight Authority (Virginia Space), as well as members of the Wallops Contractors' Association. This will build on the existing Space Grant between ESCC and NASA Wallops and Goddard and the MOU between ESCC and Virginia Commercial Space Flight Authority.

Preparation of the grant is projected to be completed this summer with submission of the grant in July of 2023. If approved the finalization of curriculum and purchase STEM lab equipment will carry through the fall with the hope of targeting enrollment for K through 8th grades by January 1, 2024 with the high school lab schools opening in Fall, 2024. Initial start-up grant amounts will be up to \$1 million to make one-time purchases necessary to launch a lab school; and \$75 million for per-pupil operating funds to support ongoing expenses for operation and maintenance of a lab school.

Man convicted of Sweet 16 fete shooting will be held

An 18-year-old Cape Charles man was sentenced to a term of indeterminate commitment to the Department of Juvenile Justice for shooting into a car after a birthday party and injuring a classmate.

The shooting occurred after a Sweet 16 party at the Mary N. Smith Cultural Enrichment Center in Accomac.

Jalil Naheem Galloway, originally charged as an adult with malicious wounding and shooting into an occupied vehicle, pleaded guilty in February to the lesser charges of unlawful wounding and unlawfully shooting into an occupied vehicle in an agreement with the commonwealth.

In January 2022, police responded to a 911 call from a juvenile who told them she was shot.

The girl identified the shooter as Galloway, said Commonwealth's Attorney Spencer Morgan.

She was a passenger in a car with another teen who drove her to the hospital. Partygoers speaking with a deputy at the scene described chaos and fighting as people were leaving the party.

Shots were fired. A witness said she saw the defendant standing in front of the victim's car. She said he first fired a shot into the air then raised his weapon

and fired directly into the vehicle. The car sped away and the girl realized she had been shot in the chest.

At Galloway's sentencing, defense attorney Thomas Northam called Laura Lembke, coordinator for alternative education in Northampton County schools, to the witness stand.

She said Galloway worked hard and made good grades since the incident. She said he worked diligently and that there were no problems with him.

"Jalil made a horrible choice," she told the court.

Galloway's juvenile probation officer, Phermaine Wright, testified that Galloway struggled in school before the shooting.

She said he assaulted a worker at the school and was involved in a fight in school in 2021.

Judge W. Revell Lewis III addressed the defendant directly. "The facts are you have never admitted or denied the shooting. You fired shots into the vehicle." Lewis then held up a photograph of the red bra the victim wore to the birthday party that night. It clearly showed a bullet hole in the cup of the garment.

"How she survived that wound is a miracle," he said.

Morgan said Galloway could be held until he is 21 but will be brought back to court periodically for review.

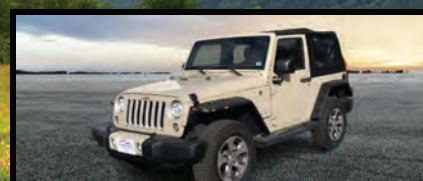

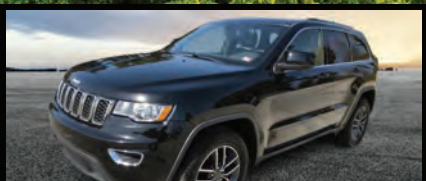

Remembering Dr. Arthur Carter's community spirit

Not everyone enjoys examining community issues, indentifying the problems, finding ways to help, and working toward solutions. Our busy lives usually don't leave much time for such intricate involvement. And sometimes, it's just easier to watch television and pretend the community programs don't exist.

And then there was Dr. Arthur T. Carter, whose words, deeds, and scholarship were reminiscent of Socrates, who famously said that the unexamined life wasn't worth living.

Carter, a physician, died April 5 at the age of 76. He gave up his medical practice to throw himself at problems of housing, employment, and more.

He stopped examining people medically but continued examining the cultural issues that seem to beset and divide the Eastern Shore.

Carter also possessed the charisma and intelligence to inspire and garner followers. He was a local leader who actually had the gravitas needed to lead.

What can we take away from his life and death?

We can continue to find creative solutions to problems of all sizes. Remember when Carter suggested placing a African American Union soldier on the Eastville courthouse green next to the Confederate soldier mounment? It came at a time when communities were removing Confederate statues. Carter advocated an improvement in displaying a controversial aspect of our nation's history instead of erasing it.

In Carter's memory we must also be honest about examining our community problems and energetic about solving them. Our involvement, like his, can be a tremendous force for good.

Americans are 25 times more likely to be killed in a gun homicide than in other high-income countries. The U.S. has four percent of the world's population but 35 percent of its gun suicides. Every country has its mental health challenges. The difference is that in the U.S., we make it easy for

people in distress or in crisis to buy and use a gun.

In Virginia last year, some gun-related bills were passed by the House of Delegates but defeated by the state's Senate:

■ HB 204 — Would have

allowed individuals to acquire guns before their background checks were complete.

■ HB 509 — Would have repealed the extreme risk protective order law that separates people from their firearms if they pose a risk to themselves or others. So-called "red flag laws" take guns away from people experiencing a mental health crisis.

You can help save lives. Call two Republican legislators: Virginia Delegate Robert Bloxom and U.S. Rep. Jennifer Kiggans. Your message is three-fold: First, doing nothing to stop gun violence is not an option; further loosening of protections already on the books is unacceptable; and, finally, the federal government needs to enact red flag law protections across our country.

No small town in America is safe. As I write this, an Alabama mass shooting at a 16-year-old's birthday party left four dead and 32 injured. Please make your calls now to legislators. Every minute counts.

Railway Museum and town appearance draw kudos

Ellen Johnson, Eastern Shore Railway Museum director, thanked everyone during a Parksley Town Council meeting who helped with the town Easter egg hunt sponsored by the museum.

“The town has really grown and it’s looking beautiful. (There were) many compliments,” she said, adding the museum plans to have an ice cream social for the public July 8, including children’s activities and a model railroad display.

Visitor numbers at the museum in March doubled or more compared to last March, according to Johnson.

“They are coming in and they are seeing the town — the town is looking great,” she said.

Mayor Frank Russell also said he is hearing many compliments about the town’s appearance.

“You can say we sneak into chicken houses and break eggs for meanness, but you can’t say we’re not getting things done — I mean, we are getting things done,” Russell quipped, giving credit to Councilman Henry Nicholson in particular for his efforts to improve the town’s appearance.

Councilman Ricky Taylor said a couple who visited the museum, who “make it a point to go around to rail-

road museums different places,” said the Parksley museum’s dining car “is by far the nicest one they’ve seen yet.”

Parksley park

Karen Eichelberger spoke on behalf of a committee created to improve the Parksley park.

The committee decided to have two groups, one for park volunteers and one group that will be working to create a nonprofit organization.

“They are looking for directors right now — at least three directors,” she said of the second group.

The committee applied for two grants, including one from Lowe’s.

Lowe’s grant awards will be announced in mid-June.

A second grant was not awarded to the group because the grantor typically does not award grants unless an organization has 501(c)(3) (nonprofit) status.

The committee plans to hold a public picnic day at the park this summer.

“When I first moved to Parksley, 40-something years ago, they had a picnic at the park and they had sack races and watermelon seed spitting contests — we want to do something again like that to help raise awareness for the park and to help raise awareness for our committee,” Eichelberger said.

Additionally, funds for the park are being raised through a bingo night at the firehouse this month, she said.

Among park improvements being considered is an asphalt walking track around the perimeter if funding is available, according to the council discussion.

Downtown revitalization

Russell said the town received verification that the granting agency will pay for certain projects in the final phase of a downtown revitalization grant.

“That’s good for us. It’s going to get a whole lot of things done in town that we won’t have to spend Parksley taxpayer money on,” he said.

The projects to be paid for with the remaining grant funds include additional new fencing along the back of the Farmers Market and elsewhere downtown, flower planters, new globes for streetlights, additional lighting in the downtown stage area, and possibly awnings, and demolition of a derelict building on Bennett Street near the former railroad tracks, according to Russell.

New water meters

New automated water meters will be installed in Parksley starting April

20, according to Councilman Henry Nicholson.

Residents “will get plenty of notification,” including door hangers, he said, adding installation of all meters should take around 30 days to complete.

The meters were paid for with federal funds resulting from the American Rescue Plan Act.

Russell said the new meters will save the town time and money.

“The way we are doing it now, it takes about three days to read the water meters now. When we get these new wireless meters in, we can do it in an hour, two hours,” Russell said.

The information will be transmitted automatically to computers, lessening the chance for human error.

In other news, the town council appointed Mike McCready zoning administrator.

Library update

Construction of the new Eastern Shore Regional Library in Parksley is nearing completion, according to Russell, who said library employees have been told to start organizing the books for the move.

The date for the library foundation to move from its current quarters at the Historic Onancock School into the new library is May 5.

Eastern Shore Literacy Council gets \$5k library grant

National Home Library Foundation has awarded the Eastern Shore Literacy Council a \$5,000 grant to support the local Dolly Parton Imagination Library program.

This grant award will assist in the distribution of books each month to age-eligible children, registered for the Imagination Library through the Eastern Shore Literacy Council program.

Since the first books were mailed in November 2021, 9,812 books have been mailed and 878 age-eligible children have registered for the Imagination Library.

The National Home Library Foundation supports initiatives that develop, sustain, and promote literacy programs serving children, teens, or adults in need of reading and learning resources, with a goal of combating illiteracy and encouraging an interest

in reading and the literary arts for all ages.

Founded in 1932, this private foundation has awarded more than \$3 million to date.

Fruit flies: Getting to know the enemy — and tips on getting rid of it

Fruit flies love the Eastern Shore, and even if you keep your kitchen at an operating-room level of cleanliness, at

some point this summer you will reach for a banana on your counter and disturb a small flight of fruit flies. How do you get rid of them?

First, let's get to know the enemy. Their scientific name is *Drosophila melanogaster*, there are more than 4,000 species of the little darlings, and they exist all over the world. Fruit flies are about a tenth of an inch long, their coloring is black and gray, and they have distinctive red eyes. Females can lay 500 eggs at a time. Those

eggs hatch in a couple days, and in a couple weeks the new fruit flies can breed and produce offspring. Their top flight speed is 4 mph.

Fruit flies like to lay their eggs on overripe fruit but any moist area that contains a food source (like your kitchen sink drain or that trashcan that hasn't been emptied in a few days) will suffice as a fruit fly breeding ground. Their lifespan is one to two months.

For more than 100 years, fruit flies have been used in scientific study. The flies breed quickly and genetic studies have found, according to Upstate University, that the fruit fly "is fundamentally similar to other organisms, including mammals, at the genetic, molecular, cellular, and tissue levels."

Even though the fruit fly brain has one-millionth the number of neurons that are in a human brain, the little buzzers display behavior that is remarkably humanlike. One study, for

example, found that male fruit flies that were rejected for mating would then overindulge in food sources providing a high level of alcohol. No reports yet on if those rejected suitors also showed an affinity for songs by George Jones.

Here are some tactics for getting rid of fruit flies. Your grandmother knows more.

■ As soon as you bring fruit into the house, run water over the fruit to wash off flies, eggs, and larvae.

■ Keep fruit and vegetables in the fridge. This advice might ignite the to-refrigerate-or-not-to-refrigerate-bananas debate. Some sources say that putting ripe bananas in the fridge is perfectly fine. But anyone who remembers the Chiquita Banana jingle knows: "Bananas like the climate of the very, very tropical equator. / So you should never put bananas in the refrigerator." The lyrics work best if you can tap into your

inner Carmen Miranda and dance the samba, preferably with bananas on your head, while you sing.

■ Pour boiling hot water down your kitchen drain every few days in the summer.

■ In a small bowl pour in some apple cider or red wine vinegar with a little squirt of liquid dishwashing soap. Microwave the mixture for 20 seconds to get the aroma going and place the bowl where fruit flies are active. The flies will come in for a sip, and the soap will reduce surface tension, trapping the flies as soon as they alight.

■ You can also put plastic wrap over a bottle of beer or wine that hasn't quite been finished (or over a bowl of apple cider vinegar), punch small holes in the plastic, and the fruit flies will find their way in ... but not out.

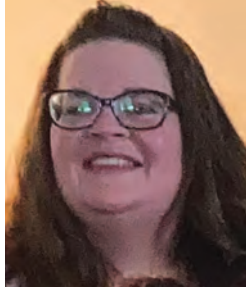

The mural – one of three that will be executed in the downtown district this spring and summer – is a project of OMS and was funded by grants from Virginia Main Street, a program of the Virginia Department of Housing and Community Development.

"OMS is committed to bringing public art to the downtown with murals that reflect the unique character of our community," said Cindy Holdren, chairperson of the OMS Mural Committee. "The project is intended to engage residents and visitors, hopefully increasing foot traffic to our businesses."

OMS is grateful to business owners, Mary and Elon Benaknin, for embracing the concept of a mural and offering their building for this project.

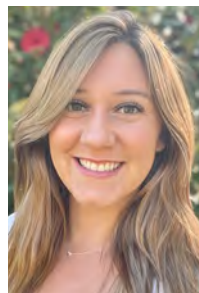

plied for a permit to build any before Manuel.

Northampton has fewer than 300 hotel rooms south of Eastville and a need for more accommodations for one-night stays, Parr said.

He thought the tourist cottages would appeal to citizens more than another "concrete box" on the highway.

About two months after Northampton supervisors denied Manuel the major SUP, they voted to remove tourist cottages from the county zoning ordinance, saying their definition was "outdated and imprecise."

Martingayle called the decision "arbitrary and capricious," particularly because a similar item in the zoning ordinance, farm cottages, was left untouched.

But Lewis disagreed. The board of

supervisors is a legislative body that decides which land uses are appropriate, he said.

The land use for which Manuel applied required a major SUP, which supervisors could grant or deny. Manuel was not entitled to a permit; therefore, he was not deprived of his property rights, Lewis said.

The judge noted that county officials had suggested an appropriate use for Manuel's land. The 40 acres of farmland could contain two homes, each with an accessory dwelling unit, for a total of four units that could potentially generate rental income. Manuel rejected that idea.

Lewis said Manuel had been denied neither his property rights nor due process. The judge ruled in favor of the board of supervisors.

In Northampton, not one tourist cottage stands as a reminder of its short term in the county's zoning ordinance.

J.T. Holland, indefatigable State Farm agent, keeps going

Youngkin endorses Bloxom, 41 others, in campaigns

Gov. Glenn Youngkin announced he is endorsing Del. Rob Bloxom along with 41 other General Assembly incumbents in their bids for re-election this November.

Youngkin in an April 12 announcement backed candidates he said were key team members who supported his Day One game plan.

"18 months ago, Virginians came together to say we want a team who will work to make the Commonwealth the best place in America to live, work, and raise a family. We went to work—empowering parents and promoting excellence in education, reducing taxes, standing with our law enforcement, and building support for Virginians struggling with mental health issues. But we have more to do, to strengthen the spirit of Virginia and deliver results for the Commonwealth. I'm excited to endorse these key team members who all leaned in to help us achieve our Day One Game Plan," Youngkin said.

Bloxom, 60, first was elected to the House of Delegates in a special election in 2014.

Bloxom owns Shore Tire & Auto in Onley, two NAPA Auto Parts stores, and Egret Pointe Seafood Company.

Youngkin's endorsement also includes Sen. Bill DeSteph, of Virginia Beach, the GOP candidate for the new Senate District 20, which includes the Eastern Shore and parts of Virginia Beach and Norfolk.

Sen. Lynwood Lewis, a Democrat who represented the Shore in Richmond since 2004, first in the House of Delegates and then in the Senate, recently announced he will not seek another term in office, after redistricting put him in the same district as DeSteph.

DeSteph has been in the Senate since 2016 and before that was a delegate since 2014.

The new district leans Republican, according to the Virginia Public Access Project.

The 42 candidates endorsed by Youngkin all have already secured their party's nomination and will be on the ballot in November.

The Spirit of Virginia PAC, a Republican political action committee, recently announced it has raised a record \$2.75 million in the first quarter of 2023.

Hearing set for 40-unit senior housing center near Onancock

The Accomack County Board of Supervisors set a public hearing for May 17 to take comments about a proposed 40-unit senior housing development across Hermitage Road from the existing Commonwealth Senior Living facility near Onancock.

The hearing is about an application to rezone the property from the agricultural district to the village development district.

The Accomack County Planning Commission after holding a public hearing in March recommended approval of the rezoning, with the proffer that the units will be for sale or lease by the owner and that at least 80% of the units will be occupied by households with at least one member age 55 or older.

A description included with the application says the adult living community is under separate but related ownership from Commonwealth Senior Living and that it “is intended to complement the level of care and senior housing options available for residents in the community.”

The residences are described as “patio home style.”

The application was submitted by MCAP Eastern Shore Land LLC.

The use is allowed with a conditional use permit in the village development zoning district.

Jester’s gestures clear Accomack court

This court Jester wasn’t so funny. Onlookers on one side of the Accomack Circuit Court cleared out quickly as deputies restrained an unruly defendant.

Lance Carl Jester, 38, of Parkesley, argued with the judge and then refused to go quietly into the courtroom’s holding cell.

Jester is charged with abduction, strangulation, rape, and an attempt to escape from jail.

Defense attorney Tory Delpierre asked the judge permission to withdraw from Jester’s case, saying attorney-client trust was broken.

When Judge W. Revell Lewis III

agreed to appoint another attorney, Jester asked to speak.

He told the judge he wanted to represent himself in court.

Lewis agreed that he could but told him an attorney needed to be there with him to advise him because of the seriousness of the charges and appointed another attorney.

After hearing that, Jester began shouting at the judge and attempted to continue arguing even after the judge told him his case was concluded.

Jester continued shouting at the judge as a bailiff tried to lead him from the courtroom. It took several deputies to get him under control and shouts could still be heard in the courtroom as he was taken to the holding cell.

Chincoteague man gets prison time

An Accomack County man will get prison time for attempted murder, a judge has ruled.

John Joseph Ellis, 64, of Chincoteague, will spend eight years of active time in prison for his December 2022 convictions of two counts of attempted first-degree murder, shooting at an occupied dwelling, armed burglary, and felony property destruction.

In May 2019, Ellis went to a home in the Piney Island area of Chincoteague armed with a handgun he had recently bought from a friend, said Commonwealth’s Attorney Spencer Morgan.

He called this “a serious case of what

can go wrong when you don’t prioritize mental health.”

He said Ellis had plans to kill two former employers he said had been “hurting him” for a long time.

A security video obtained from the scene showed Ellis arriving by moped, pulling the 9mm handgun out of his pocket, and firing shots through the front door of the house.

The men were out of the area when the crimes occurred but are concerned he may come after them again if given the opportunity, Morgan said.

In addition to the eight years of active incarceration, Ellis faces 27 years of suspended time. He is required to be on supervised probation for five years and on good behavior for 10 years.

Woman bequeaths \$700,000 to Accomack Sheriff's Office

An Onancock woman who died last year left most of her estate to the Accomack County Sheriff's Office — a legacy that will pay for a college scholarship, among other benefits.

Around \$700,000 from the estate of Ann Smith, a former Nancock Gardens resident, will go to the Sheriff's Office, according to Mike Mason, Accomack County administrator.

Sheriff Todd Wessells said part of the money will be used to establish an annual scholarship for Accomack County residents who pursue a college degree in criminal justice.

The scholarship will be managed through a new nonprofit, Accomack County Sheriff's Office Foundation Inc.

The remaining funds will go to pay for equipment and facility needs of the sheriff's office.

The Accomack County Board of Supervisors will be asked to appropriate the bequeathed funding based on the sheriff's requests.

Library opening inches closer

An occupancy certificate for the new regional public library in Parksley was issued March 20, effectively ending a years-long effort to construct a new, larger facility to replace the aging library in Accomac.

Still, the move-in, which was scheduled to begin April 24, was delayed after the library foundation and board of trustees sent a letter April 15 citing several concerns they had with the draft lease agreement, including that the lease could adversely affect a 2018 memorandum of understanding between the two library entities and the county.

Board Chairman Robert Crockett after reading the letter met with County Administrator Mike Mason and the county attorney and asked Mason to prepare a presentation for the board.

Mason said the county does not have "nefarious" intentions regarding the library, noting the county borrowed more than \$2 million to finance construction; appropriated an additional \$223,000 in federal ARPA funds to address roof issues; moved forward with construction despite no commitment from Northampton County at the time; absorbing all project management, administrative, legal, procurement, and other related costs.

"There are, combined, thousands of hours spent on this project. ... It has been a tremendous

draw on the county's resources," he said.

Mason told the board of supervisors Wednesday the lease does not nullify the memorandum even though it mentions only the library trustee board, not the foundation.

Among other issues library officials were concerned about was that the lease terms suggest the county could be able to borrow money against the library's equity.

Mason said the library board would have to agree to any such action.

The Accomack County Board of Supervisors Wednesday approved the lease agreement between the county and the Eastern Shore Public Library Board of Trustees, under which the library board will rent the new library for \$1 total for a term from April 2023 to June 1, 2039 (the maturity date of the bonds issued by the county to pay for the library construction).

The library board of trustees must sign the lease agreement for the process of moving in and opening the new library to proceed.

The library property will be conveyed to the library trustees at the end of the lease, according to the terms.

The trustees are responsible for the cost of all utilities and services, while the county will insure the building and will maintain and repair the building, equipment, grounds, and parking lot on a reimbursement basis.

The library board is responsible for insuring the contents of the library, which also includes the Heritage Center, a repository for archival documents and other items related to Eastern Shore history.

Mary N. Smith Center gets grant

The board of supervisors authorized the county administrator to execute a planning grant agreement with the Virginia Department of Housing and Community Development related to the Mary Nottingham Smith Cultural Enrichment Center near Accomac.

Accomack County previously was awarded a planning grant for the center conditional on the county completing certain activities, which now have been accomplished, according to Mason.

Activities completed to date include holding an initial public meeting and management team meetings, submitting a recent county financial statement, and creating a draft request for proposal for engineering services.

After completing those activities, the county has qualified for the full planning grant award

of \$50,000.

The money will be used to complete required tasks, including creating the management team, developing a preliminary engineering report for the facility, creating a staffing and operations plan, creating a furniture, fixtures, and equipment plan, and compiling the proposed best use of the center based on results of community input and assessments.

Once those tasks are completed, the county and the MNS center "will be positioned well to apply for VDHCD construction funds to renovate the former school," according to Mason.

Those construction grants can total as much as \$1.7 million, according to Mason.

The center formerly was the county's only public high school for Black residents and later served as a middle school after desegregation, until it was closed around 2004.

VDOT roads hearing is slated

A public hearing will be held in May to receive comments about the state highway department's six-year road plan for Accomack County.

Chris Isdell detailed the plan for the board of supervisors Wednesday.

The active project list has been reduced to include only top priority projects that realistically can get funded and be constructed, Isdell said, adding that the county should maintain a list of prioritized "shelf projects" to be considered for inclusion as projects are completed or priorities change.

Total projected funding for secondary road improvement in the county in the next six years is \$617,025, of which \$126,171 is to improve unpaved roads.

The top priority is Route 602 (Lee Street) which is fully funded at a cost of just over \$6 million and is set to be completed in November.

Accomack's "shelf projects" currently include Redwood Road and Locustville Road, for which a funding source and project scope are yet to be determined.

Supervisor Donald L. Hart Jr. noted some secondary road projects have been on Accomack's list for some three decades.

The county's top priority for unpaved roads is Matchotank Road, which is fully funded at a cost of \$88,900 and should be completed in 2025.

Isdell said county officials over the next year should identify a new future project or projects to add to the list.

Bills signed by Youngkin include several supported by local delegation

Gov. Glenn Youngkin signed more than 700 bills into law last month, several of which were sponsored by Virginia’s two state legislators from the Eastern Shore, Democrat Sen. Lynwood Lewis and Republican Delegate Robert Bloxom.

Affordable housing

Both legislators were patrons of House Bill 1805 (Senate Bill 1401), which allows the Virginia Resources Authority to finance community development housing projects, including those that benefit low-income families.

The Virginia Resources Authority was created by the General Assembly nearly 40 years ago to support community investments.

The VRA provides revolving fund loans with below-market interest rates and issues bonds (loan funds) with the obligation of the state.

Housing will be added to the list of project types the VRA already supports, which includes water, wastewater, public safety, transportation, and broadband internet.

Community resilience

Lewis was a patron of Senate Bill 1187 (House Bill 1634), encouraging Virginia localities to include resilience strategies in their comprehensive plans.

On the Eastern Shore, resilience often means coastal resilience, such as preparing for and responding to coastal flooding.

In SB 1187, resilience means protecting the environment, the health and social well-being of citizens, and the economy from multiple hazards, not just coastal threats.

The bill also states that comprehensive plans must include plans to support community development, affordable housing, and transportation and broadband infrastructure.

Wetlands mitigation

Bloxom was a patron of House Bill 1950 (Senate Bill 1160), which directs the Virginia Marine Resources Commission to review and update its wetland mitigation bank guidelines and regulations.

Wetland mitigation banks are used by developers to purchase wetland offset credits and compensate for wetlands that were unavoidably destroyed during a construction project.

Typically, a new wetland is created in another location, and one acre of wetlands equals one offset credit.

Menhaden

Lewis was a patron of Senate Bill 1388, which directs the Virginia Institute of Marine Science to study menhaden, small fish similar to herring that are generally not consumed by humans but are used as bait and to make fertilizer, animal feed, and fish oil health supplements.

Researchers will study the ecology of menhaden, the impacts of Virginia’s menhaden fishery, and the economic significance of the menhaden in Virginia waters like the Chesapeake Bay.

The researchers will report their findings in writing to the Secretary of Natural and Historic Resources and the chairs of both related House and Senate committees.

Official pony of Virginia

Both legislators were patrons of House Bill 1951 (Senate Bill 1478), making the Chincoteague pony the official pony of Virginia.

Other state emblems and designations established or affirmed by the bill included: bird, Northern cardinal; dog, American foxhound; insect, tiger swallowtail butterfly; tree (and flower), American dogwood; freshwater fish, brook trout; saltwater fish, striped bass; shell, oyster; boat,

Chesapeake Bay deadrise; and beverage, milk.

Governor’s amendments

The governor offered amendments to several other bills supported by the Eastern Shore politicians:

Foreign interests in farm land

Bloxom was a patron of House Bill 2325 (Senate Bill 1438), which would prohibit U.S. foreign adversaries from acquiring interest in Virginia’s agricultural land.

Any foreign government would be prohibited from any future purchasing, leasing, or otherwise acquiring or holding interest in farm land in the state.

Virginia’s Department of Agriculture and Consumer Services will be required to report data annually to the General Assembly and governor, including the amount of agricultural land under foreign ownership, the percent change of foreign ownership of agricultural land, and the uses of the foreign-owned land.

Renewable energy standards

Lewis was a patron of Senate Bill 1231 (House Bill 2026), which would allow certain biomass-fired power plants to qualify as renewable energy sources.

Biomass energy is typically produced from plant material such as corn, soybeans, or algae.

Ethanol, which is made from corn and often a component of gasoline blends, is a well-known biomass fuel.

The bill removes the requirement for Dominion and Appalachian Power Company to retire its biomass generators by the end of 2028.

The governor offered several amendments to this bill, including one that would allow new nuclear generators and zero-emission hydrogen generators also to comply with Virginia’s renewable energy standards.

SSCC applications are being accepted

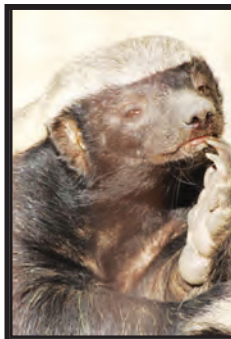

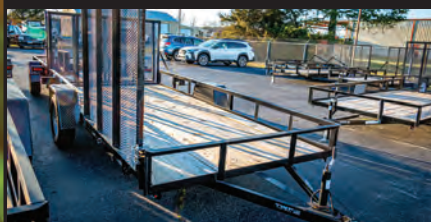
