

Prosecutor: ‘We want to make the right decision’

One month after pedestrian fatality on Nocks Landing Road near Atlantic, investigation of driver continues

Accomack County’s prosecutor is continuing an investigation into an April 12 incident resulting in a fatality and two injuries on Nocks Landing Road near Atlantic.

The Accomack Commonwealth’s Attorney’s office will determine if charges are brought against the driver of a vehicle that hit three in the accident, killing 26-year-old Erika Cherrelle Bailey, of Atlantic.

“There are no charges as of yet but it is still pending inves-

tigation,” said Commonwealth’s Attorney J. Spencer Morgan Tuesday.

The accident occurred around 6:30 p.m. on Wednesday, April 12, when Bailey and her boyfriend, Duane Lee Turner, 39, were teaching her 6-year-old daughter to ride a bicycle on

Nocks Landing Road, according to police reports.

Driver Jessica Greenley Waterfield, 36, of Atlantic, was heading east in a 2021 Honda Pilot sport utility vehicle when the SUV struck them from behind, killing Bailey on impact, according

A tribute to late artist and Tangier native Willie Crockett is on display outside his former studio in Onancock.

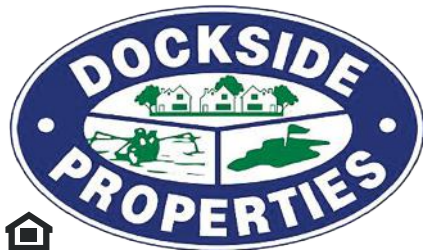
The larger-than-life mural of Crockett’s painting matches the celebrated artist and storyteller’s personality.

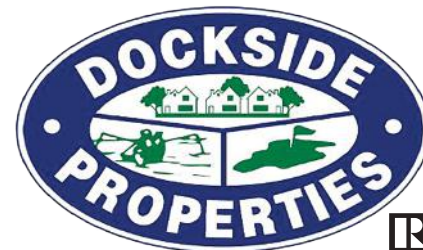

The Accomack County Department of Public Works is pleased to announce the countywide **"Spring Clean-Up"** to be held on **Saturday May 13, 2023**. In an effort to encourage citizens of Accomack to remove unsightly refuse from their yards, homes, and communities, **the Accomack County Board of Supervisors will waive tipping fees at the North Landfill and South Transfer Station for residential waste and recyclable materials brought in on this day.** The waiver will also be open to non-residents possessing an Accomack County Solid Waste Decal. Commercial for hire waste haulers will be required to pay standard tipping fees.

Landfills will be open on Saturday May 13, 2023 from 8:30 am to 4:00 pm to accept residential garbage, yard waste, and construction/demolition debris. The landfill will also accept the following recyclable materials:

- Tires (car and small truck only "LIMIT" 12 per person/day)
- Used Motor Oil, Scrap Metal, and car and truck batteries.

Recycling materials, such as plastic bottles, milk jugs, detergent bottles, any #1 or #2 plastics, newspapers, magazines, catalogs, junk mail, telephone books, cereal boxes, metal and aluminum cans, may be recycled at any of the County's 7 Convenience/Recycling Centers "FREE" year round.

Landfills and Convenience Centers will not accept materials deemed to be hazardous, such as: Paint, Pesticides, Biological hazards, asbestos, and heavy metals. Please check with the attendants at these sites as to where and how to dispose of hazardous materials.

The Department of Solid Waste looks forward to working with the citizens of Accomack County on this program and encourages everyone to mark their calendars for the second Saturday of May every year! A "FALL CLEAN-UP" will also, be held on the second Saturday in October. This year's event will be October 14, 2023. Bloxom man fatally injured in Sunday crash on Saxis Road

An Accomack County man was fatally injured on Sunday, May 7, during a two-vehicle crash on Saxis Road.

Adam Eugene Godwin, 32, of Bloxom, was killed when the vehicle he was driving, a 2003 Ford Explorer, crossed a double solid line into oncoming traffic, state police reported.

The incident happened at 8:29 a.m. at the intersection of Saxis and Will

Fisher roads, near the Makemie Park community.

Godwin's vehicle hit a 2000 Mitsubishi box truck driven by 82-year-old Elize Lee Jacobs of Temperanceville.

Jacobs was not injured in the crash. Godwin died upon impact and was not wearing his seatbelt at the time of the crash, according to state police spokeswoman Michelle Anaya.

Vacant Melfa agriculture complex comes under local ownership

The Accomack County Economic Development Authority is the new owner of the Robert S. Bloxom Shore Agricultural Complex off Airport Drive in Melfa.

The land, which includes 30 acres, several large buildings, and commercial freezer space, has been largely unused in recent years, but the EDA hopes to change that.

"It's a golden opportunity for us," said Del. Rob Bloxom, a member of Accomack's EDA.

"We saw great potential for ... new industry to come in. We're always looking for people to come here and work," EDA Chair Stella Rohde said.

The EDA plans to lease or sell the space, but first an appraiser will assess the buildings' value and price point for renting its refrigerated and

other spaces, officials said.

That should happen over the next month, Bloxom said.

The transfer comes after the Virginia Department of Agriculture and Consumer Services owned the property for decades.

VDACS came to hold the Melfa market after a state-led initiative in the 1990s, when the Virginia Farm Market Board recommended locations for a network of farmers markets across the Commonwealth.

The first phase of the market aimed to provide a cooperative where small farmers could sell Eastern Shore favorites such as sweet potatoes, potatoes, and tomatoes.

A later addition gave commercial watermen the ability to flash freeze and store seafood.

In 2011, former Gov. Bob McDonnell dedicated the facility to Bloxom's late father, longtime Delegate and

Eastern Shore native Robert S. Bloxom, who was Virginia's first Secretary of Agriculture.

Over time, the Melfa market evolved, "leading Pacific Growers to take over the whole building for the tomato packing," Bloxom said.

When Pacific Tomato Growers left in 2020, the complex was largely empty.

The property borders Accomack County's industrial park, leading a potential tenant to approach the EDA about renting the space several years ago, Bloxom said. But VDACS by law could not rent or lease the facility to any entities outside the agriculture and aquaculture industries.

That sparked the conversation that led VDACS to transfer the property to Accomack's EDA at no cost last week.

The EDA is a political subdivision of the Commonwealth of Virginia, allowing it to take on the property.

"We're really thrilled, but we've

got a lot of work to figure out what we're going to do with it," Rohde said, calling the complex "one-of-a-kind" and a "diamond in the rough."

Bloxom noted the facility has the only commercial freezer available for rent between Norfolk and Dover, Delaware.

"I don't think that there's any facility ... like it anywhere closer," he said.

The EDA will make information on the future of the agricultural complex and opportunities to rent or buy the space public, he said. "We're going to explore all options and figure out what the best thing is for the county," Bloxom said.

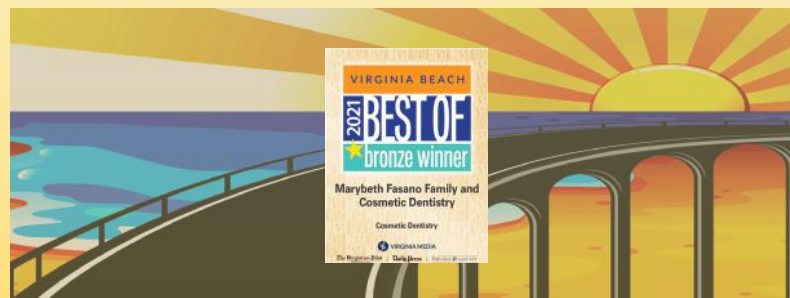

Onancock man charged after wielding knife at sheriff's deputies

An Accomack County man was arrested on Thursday, May 4, and charged with wielding a knife at sheriff's deputies and barricading himself inside a home.

Macio Lafonza Stewart, 46, of Onancock, was transported to Riverside Shore Memorial Hospital for injuries sustained during the altercation. Stewart was released from the hospital later that evening and was remanded to the Accomack County Jail.

Sheriff W. Todd Wessells said deputies responded to a residence in the 23000 block of Daugherty Road to execute a warrant for violation of probation and parole terms.

When deputies arrived on scene they encountered a female subject who advised deputies the suspect was not inside the residence.

The female was exhibiting nervous actions, making statements that led deputies to believe the suspect was there,

Wessells said.

The suspect was found in a room wielding a knife and was able to barricade himself inside. After a few hours the subject exited the room but failed to comply with orders.

The suspect was undeterred by a stun gun and a K-9 unit was deployed, allowing deputies to place the suspect under arrest. A search warrant was executed at the end of the arrest pursuant to an investigation into other incidents.

The female subject, identified as Shanice Davis, 23, of Daugherty, was arrested for obstruction of justice. Davis was held in the Accomack County Jail with bond denied.

The Accomack County Sheriff's Office was assisted by the Eastern Shore Drug Task Force, Virginia State Police, Accomack County Department of Public Safety and the Onancock Volunteer Fire Department.

to State Police spokeswoman Michelle Anaya.

Turner and the child suffered "serious bodily injuries" and were transported to TidalHealth hospital in Salisbury, Anaya said.

"I don't know how (the driver) didn't see us on a straight road," Turner said in an April 17 interview with the Post.

He also contradicted police reports that they were teaching the child how to ride a bicycle.

"We were just taking a walk," he said.

Neither speed nor alcohol were contributing factors in the crash, Anaya said.

Waterfield and her 3-year-old passenger were not injured in the crash, according to police reports.

An online petition advocating bringing charges against the driver

had drawn 1,500 signatures in just two days.

Several community members contacted Morgan's office following the incident, an April 18 statement from the Commonwealth's Attorney office said.

Morgan said Tuesday the investigation is operating "on a normal timeline."

"I would like to have some sense of the direction we're heading by our next term day" June 5, he said, adding that timeline is only a goal.

"One of the reasons we're taking so much time is we want to make the right decision," Morgan said.

"Crime doesn't stop when we have a serious incident like this, so we're trying to both pay attention and be sensitive to this" while addressing new cases, he said.

He said the Commonwealth's Attorney's office will notify the media once a decision has been made regarding any charges against the driver.

More action, less talk needed with former Accomac Primary

In the Sept. 16, 2022, edition of the Eastern Shore Post, this page advocated saving the former Accomac Primary School and restoring it into county and school board offices. That still is the best outcome. We are eager to see it.

But anything involving the stately school building moves at a glacial pace — and apparently will continue to.

The Accomack School Board recently announced a committee will assess a recently completed feasibility study. The committee later will meet with the Accomack Board of Supervisors. There have been promises that it will be a transparent and open process. It also sounds like a long process.

The committee includes professional educators and school board members. That's nice, but not all of our top educational administrators have advanced degrees in architecture or construction management. They're trained to build people — not office space.

Further, it doesn't seem like any of the prospective committee members live in the town of Accomac, whose residents are overwhelmingly in support of remodeling the school.

If the school board wanted to make it open and transparent, it would put Accomac Town Council members on this new committee and would get everyone's input — residents, taxpayers, the board of supervisors — how to best use the school and the property.

It should work right now with the board of supervisors to fund an architectural plan to renovate the school — and fund the actual renovation.

More action than talk is needed. We can all agree that the future of Accomack Primary School has been talked to death.

His favorite clam fritter

To the editor:

In response to Ted Shockley's April 14 column on the perfect clam fritter recipe, my go-to place for a clam fritter sandwich is the Wachapreague Volunteer Fire Co. Carnival.

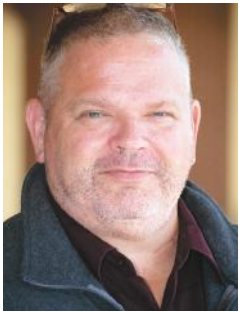

For Mother's Day, a belated thank-you for the schoolwork help

Sunday will be the second Mother's Day since my mom died.

The day is a haunting reminder of the many times I didn't adequately thank her for something or another.

For example, I should have thanked my mother profusely for doing all of those extra projects I was assigned for being in a gifted-and-talented program in elementary school.

I was a dubious and uninspired gifted-and-talented student. At the time, I was focused on more important stuff, like baseball cards.

The only real academic gift I had was my mother — she completed practically all of those gifted-and-talented assignments for me.

And the only real academic talent I had was convincingly passing off all the work she did as my own.

I know there are students in these gifted-and-talented programs who are indeed gifted and talented and do all of their extra schoolwork themselves.

(There probably even are elementary school students who do science fair projects on their own, without their mothers' involvement. I just haven't met many.)

My father's work took our family from the Eastern Shore of Virginia to Delaware when I was in first grade. I found all of my new friends left our regular class several times each week to attend the gifted-and-talented class.

I lobbied my mother to get me into the gifted-and-talented program. She thought it might be good for me. I had other motives.

I thought leaving the regular class several times each week sounded like a good idea. Perhaps, I thought, there would be less school work to do. I was completely in favor of that.

I took the gifted-and-talented program admission test. I remember exactly what my mother, who was always blunt, said when she got the results.

"You made it by the skin of your teeth," she said.

"I don't have any skin on my teeth," I said, confused.

"Exactly," she said.

So for second grade, I became an official gifted-and-talented student, and enjoyed the cachet such an esteemed designation bestowed.

You can imagine my shock when I learned how much extra schoolwork was involved in the program.

My strategy was to ignore the gifted-and-talented projects until 7 p.m. on the day before they were due.

You can imagine how disappointed Mom was in my procrastination and disinterest.

"Mom, for gifted-and-talented class I have to do a three-page paper on the presidency of Jimmy Carter," I'd say after a full Sunday of trading baseball cards.

"When is it due?" she would ask.

"Tomorrow morning," I would answer.

"When did you learn about this assignment?" she would ask.

"Two months ago," I would say.

My mother wrote many papers for gifted-and-talented class that I would then rewrite in my own horrible handwriting, just to make the whole fraud look less fraudulent.

One Sunday I announced that I had an entire project on whales due the following day. She was incredulous but helpful.

She whipped up a batch of papier-mâché, sculpted a perfect whale the size of a shoebox, and painted it that night after I went to bed.

The next morning, I traced out her report in my own handwriting. My whale and paper were the envy of the gifted-and-talented class.

It is all very embarrassing now. And why, I wonder, did my mother continually bail me out?

Perhaps she feared my own academic irresponsibility might negatively reflect on her.

Perhaps she knew my inclusion in the class was important to me so she helped with the assignments.

Perhaps she knew entire gifted-and-talented programs (and science fairs) across our country would cease to exist if dedicated mothers didn't complete their sons' projects.

Perhaps she loved me so much that she wanted to shield me from my own irresponsibility.

In sixth grade, my father's work brought us back home to the Eastern Shore of Virginia.

Mom and I agreed that, with the change of school districts, we were finished with our experiment in gifted-and-talented classes.

Besides, she had learned enough about whales and the presidency of Jimmy Carter. She was ready to focus on other pursuits.

I don't remember adequately thanking her for all of the papers she wrote, experiments she conducted, and projects she completed for my gifted-and-talented classes.

Thank you, Mom, in case you can read this in the hereafter. You did an excellent job on my gifted-and-talented projects. I deeply regret that you had to do them. And I am thinking very lovingly of you this Mother's Day.

In accordance with the requirements set forth in Section 58.1-3524(C)(2) and Section 58.1-3912(E) of the Code of Virginia, as amended by Chapter 1 of the Acts of Assembly (2004 Special Session 1) and as set forth in item 503.E (Personal Property Tax Relief Program) of Chapter 951 of the 2005 Acts of Assembly any qualifying vehicle site used within the County commencing January 1, 2023 shall receive personal property tax relief in the following manner:

- Personal use vehicles valued at \$1,000 or less will be eligible for 100% tax relief;
- Personal use vehicles valued at \$1,001 to \$20,000 will be eligible for 41.0% tax relief;
- Personal use vehicles valued at \$20,001 or more shall only receive 41.0% tax relief on the first \$20,000 of value; and
- All other vehicles which do not meet the definition of "qualifying" (business use vehicles, farm use vehicles, motor homes, etc.) will not be eligible for any form of tax relief under this program.

In accordance with Item 503.D.1., the entitlement to personal property tax relief for qualifying vehicles for tax year 2005 and all prior years expired on September 1, 2006. Supplemental assessments for tax years 2005 and prior that are made on or after September 1, 2006 shall be deemed "non-qualifying" for purposes of state tax relief and the local share due from the taxpayer shall represent 100% of the tax assessable.

Medical-delivery drone demonstration draws crowd

Tangier Islanders and others living in rural parts of the Eastern Shore might not need to travel to pick up prescription medicine soon.

A crowd including Tangier’s mayor and vice mayor gathered last Wednesday at Riverside Shore Memorial Hospital to witness a demonstration of the medical drone delivery pilot program taking flight from Onancock.

“When you look at what we’re trying to do, it’s really (to) affect the lives of patients in our communities,” said Riverside Shore Memorial Hospital President Nick Chuquin.

“I couldn’t imagine a ... better opportunity to be able to impact people’s lives in a meaningful way,” said John Vernon, co-founder and chief technology officer at DroneUp, the Virginia Beach company providing the unmanned aircraft for the program.

The Drone Medical Package Delivery for Improved Transportation and Better Patient Outcomes program will test drones as a way to deliver medicine to patients with limited transportation in rural areas.

During the demonstration, the drone hovered around 80 feet above the ground and delivered a mock medicine-containing package via a line, showing how the technology can be used to reach remote homes.

Companies already use the small, un-

manned aircraft to deliver other goods and a partnership of state and local groups saw drones’ potential to tackle challenges to providing patient care on the Eastern Shore.

“Our team spends a lot of time behind the windshield going to places just to

deliver things in some cases — or in the case of Tangier, you’ve got to wait for a ferry to be full enough to make a trip over there,” said Sally Hartman, senior vice president of strategic initiatives at Riverside Health System.

Partners in the pilot project include

Riverside Health System, DroneUp, the Virginia Institute for Spaceflight & Autonomy at Old Dominion University, the Virginia Innovation Partnership Corporation, and the Accomack-Northampton Planning District Commission.

They were awarded a \$1.9 million grant from the U.S. Department of Transportation through its Strengthening Mobility and Revolutionizing Transportation (SMART) Grant program for the drone delivery project.

“We thought it was a very practical plan to help solve these real problems,” said Elaine Meil, Executive Director of the Accomack-Northampton Planning District Commission, which submitted the grant application after VISA contacted them last year.

Theirs was one of 59 proposals awarded SMART Grant funding from a pool of over 300 applications and Virginia’s only recipient in the program’s inaugural year.

The Virginia Institute of Spaceflight & Autonomy will help oversee the project’s budget, benchmarks, and schedule, and assess flight paths and their potential impacts, said VISA Executive Director David Bowles, who is based on the Eastern Shore.

“Our charter is really to help grow the aerospace ecosystem both on the Shore and across Hampton Roads,” Bowles said, pointing to the Eastern Shore’s “tremendous assets” that make that possible.

VIPC provided seed funding for the project and grant application. VIPC has supported other pilot projects using unmanned systems, including a program to deliver COVID-19 test kits in 2020.

“Together, we can really strike a fire for innovation and do something that hasn’t been done before,” said Tracy Tynan, director of the Virginia Unmanned Systems Center at VIPC.

The medical drone delivery project is split into two stages: planning and prototyping, and implementation. In the first, the team is testing and planning delivery of prescription medications by remotely operated drones. Stage two involves deploying drones from Riverside Shore Memorial Hospital in Onancock to deliver medicine to patients’ doorsteps.

The partners have been conducting tests and plan to officially launch the pilot program next month. It will start by delivering blood pressure medicine after Virginia Department of Health data showed the Eastern Shore has one of the state’s highest rates of hypertension.

“Blood pressure is much more controlled if you take your medication regularly,” Hartman said.

The trial will involve widening circles of delivery areas and last between 12 and 14 months, she said.

It could pave the way for drone delivery of medicine in other parts of Virginia.

“We are here today because Sally Hartman asked a question: Can we do this, do you think it can make an impact, and how can we work together to do this,” Chuquin said.

“Each one of our partners ... jumped up and said, ‘Absolutely. We can do this,’” he said.

“It’s just been a great partnership from the beginning,” Hartman said.

School Board changes graduation date to help student athletes

Northampton High School will no longer hold its graduation on a Saturday so that seniors participating in spring sports won't have to choose between competing in state finals and receiving their diplomas alongside their classmates.

This year's graduation will be held on Thursday, June 8.

Otherwise, these students would have to "make a choice between two extremely momentous occasions in their life," Superintendent Lisa Martin told the school board on April 27.

Northampton has held its graduation on a Saturday for several years, a day that typically conflicts with state competitions held by the Virginia High School League.

This year's graduation originally was scheduled for June 3, but that's the same day VHSL will hold state finals for track and field.

Moving graduation to another Saturday would not have been practical, as May 27 is on Memorial Day weekend and a soccer championship is June 10.

No Accomack high school graduation is scheduled on a weekend, Martin pointed out.

She suggested changing Northampton High School's graduation day to a Thursday, which would be June 8 this year and June 6 next year.

The gym would be closed on the preceding Wednesday afternoon to prepare for the Thursday evening ceremony, Martin said.

She noted that anything preprinted with the June 3 graduation date could not be corrected, and she was

unsure if the date was printed on the diplomas.

Changing the date of next year's graduation is a "no brainer," said Chair Liz Jones.

But she wondered if moving this year's graduation would be a mistake because families might not have enough time to change their plans.

School board member Jo Ann Molera noted it was likely some families already had parties planned and venues booked for June 3, but moving the graduation ceremony would not prevent them from celebrating on the earlier date.

"I think no matter what we do, we'll get some grumbling," she said.

Molera apologized for her lack of awareness that VHSL has a five-year calendar and the school board could have prevented the scheduling mishap.

Neither did Liz Jones remember a discussion about the VHSL calendar, even though former chair and school board member Charlena Jones said it was not new information.

Thinking about the dilemma "kept me up last night," Liz Jones said. Graduating seniors who qualify for the state finals are in a "really tough situation. ... It's heartbreaking."

"I don't think a student who has earned both of these high accomplishments should have to make a decision," said school board member Charlena Jones. "I think the school should be responsible to be forward thinking and forward planning."

Liz Jones asked how students had dealt with the conflict last year. The superintendent said some students had attended graduation and others participated in the athletic competition.

Molera noted that last year, graduating seniors on the soccer team had planned to “suffer in their misery together” at their match but added that they seemed more excited about the competition than the graduation ceremony.

Charlena Jones objected to the prolonged discussion and said, “I’m just going to be frank ... everybody’s entitled to their opinions and views,” but “let’s not try to ... persuade or encourage” board members to vote one way or the other.

Liz Jones said she wanted only to hear other school board members’ thoughts on the matter.

Later in the meeting, school board members voted unanimously to reschedule next year’s graduation to a date to be determined that does not conflict with VHSL’s schedule.

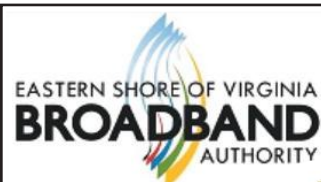
They also approved changing this year’s graduation to Thursday, June 8, in a 4-1 vote, with the chair opposed.

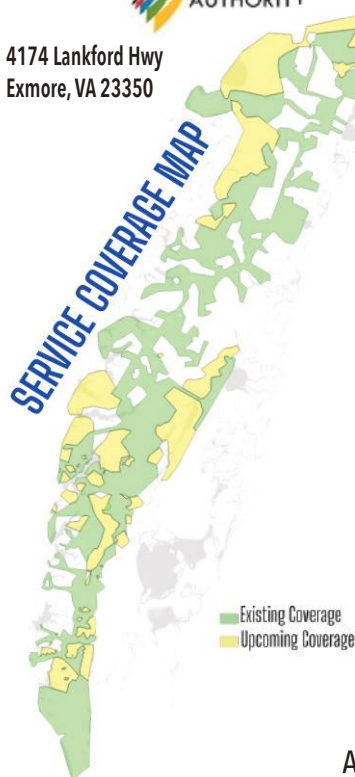

Crockett passed away in 2021 and was famed for his artistic talent, Tangier accent, and natural storytelling abilities.

The mural is one of three planned for downtown Onancock, thanks to a project by Onancock Main Street, a non-profit organization that works with the town to “ensure the continued vibrancy and preservation of historic downtown Onancock,” according to its website.

OMS is a Main Street America-Accredited program and a member of Virginia Main Street.

“We learned through Main Street ... that numerous small towns had done this and found that it helped increase their traffic — that people would come off the highway if there were numerous murals to see,” said OMS Mural Committee Chair and Board of Directors member Cindy Holdren.

“That was our goal: to help the historic part of Onancock and the businesses become more vibrant and active,” she said.

The mural concept took root several years ago and is funded by grants OMS pursued through Virginia Main Street, a Virginia Department of Housing and Community Development program, she said.

OMS selected Lubaton from among 14 applicants for its first mural on the rear wall of 9 North St., which shows a bright array of flowers, butterflies, and bees and is visible from the King Street parking lot.

The Virginia Beach artist had already designed and painted over 40 murals when he came to Onancock.

Lubaton’s second project in town is the replica of the Crockett painting on the upper story of 39 Market St., which was the artist’s studio for over 20 years.

“He was just a prolific artist and painted so much,” said Lubaton, who studied Crockett’s works that use both watercolor and oil paint to capture the movement of water featured in many of his paintings.

Crockett’s family helped choose the painting for the mural, said Holdren, who noted his son, Craig Crockett, still owns the property.

“All of the business owners... have

been great,” she said of those who have provided space for the murals.

In addition to the Crockett family, Mary and Elon Benaknin, who own the Blarney Stone Pub, provided space for the mural at 9 North St.

The North Street Playhouse will provide space for a third mural centered

on the performing arts at its 34 Market St. location. Artist Curtis Goldstein, of Ohio, will begin work on that mural later this summer, Holdren said.

OMS has applied for additional grants that might lead to future murals downtown, she added.

Crockett’s wife, Iris Morgan Crockett,

said her husband began painting after they met an artist on the way to Washington state, where Crockett moved to be a preacher.

“He said, ‘Willie, come over to our apartment. Let me show you what I’m doing with watercolor,’” she said. “The next day he went and he got everything he needed to paint, and never stopped.”

Willie Crockett soon met a professional artist from Southern California, who trained him, leading to his famous style, she said.

She called the tribute to her late husband’s work “beautiful.”

“When I came in (to the studio) and looked up, all I could do was cry,” she said. “It’s so beautiful.”

Moments like that make his job rewarding, Lubaton said.

“It’s just been an awesome experience,” he said.

Weather breaks, rewarding anglers with good fishing

Anglers were finally able to take advantage of a complete weekend of sunny skies and light winds, and the favorable conditions produced abundant catches of black and red drum, sheepshead, speckled trout, flounder, striped bass, and tautog.

Northern Shore

The Sea Hawk Sports Center reported that the Maryland

Spring striped bass season is open and anglers have been catching stripers in the shallows between Crisfield and the Virginia state line on chunks of peeler and soft crabs, fished on fishfinder rigs. Black drum, red drum, and speckled trout have also been caught as a bycatch of the striper fishery. Best action has been occurring during a rising tide and late in the afternoon as the sun sets. Flounder fishing success on the seaside has been determined by water clarity. Silversides with pink Berkley Gulp fished on top and bottom rigs have been some of the top flounder producing baits over the last week. Chartreuse and orange Gulp have also been productive combinations.

Chincoteague

Jimmy Vasiliou, at Captain Steve's Bait and Tackle, reported that the shop is stocked with fresh sea clams and live peeler crabs. Anglers fishing the Assateague Island surf have been catching and releasing large striped bass, most in excess of 36 inches. Gary

Harmison recently released a 45-inch striped bass and Caleb Gatto released a striped bass measuring 42 inches in the surf of Assateague Island.

Wachapreague

Captain Lindsay Paul described the flounder bite out of Wachapreague as "still good with some boats getting their limits." Captain Paul recommended Berkley Gulp and live minnows as the flounder bait of choice. He added that black drum are still available in the surf and he expects the offshore fishery to be starting soon. Debbie Shrieves, at the Island House Restaurant, reported Andy McMullen had the largest catch in their 32nd Annual Flounder Tournament with a

doormat weighing 6 pounds, 8 ounces. Other top catches included Paul Cell (6 pounds, 5 ounces), Carter Jarrell (5 pounds, 9 ounces), Gerald Kirsch (5 pounds, 8 ounces), and Nathan Smith (5 pounds, 7 ounces). Tara Shrieves had the top catch by a female with a flounder weighing 4 pounds, 15 ounces. Asher Hines took the Top Youth Catch Award with a 2-pound, 14-ounce fish and Lynn Huddock had the largest catch by a local with her 4-pound, 12.5-ounce flounder. Shrieves added that she weighed numerous fish in the 4 to 5-pound range.

Lower Shore

Jeb Brady, at Bailey's Bait & Tackle, commented that "the weather

seems to have broken, and anglers were (finally) rewarded with some good fishing." He reported that black drum were being caught out of Oyster as well as along the Chesapeake Bay Bridge-Tunnel on crab and clam baits. Sheepshead are being caught on cut crab baits around the pilings of the Chesapeake Bay Bridge-Tunnel. He added that catches of some "decent-sized" flounder on squid and Gulp baits have been reported inside the "Ditch" and along the Fisherman Island Bridge when clear water can be found. Sand mullet, aka whiting, are starting to show up near the Kiptopeke concrete ships. Best whiting baits have been small clam and shrimp baits. The lower barrier island surf is still producing big red drum and

New mini golf course expected to open by Memorial Day

The owners of a new business in Cape Charles hope to hit a hole-in-one with locals and tourists alike this summer.

Tom and Katie Austin are opening Cape Charles Mini Golf, the only miniature golf course in the little Chesapeake Bay beach town that welcomes thousands of visitors every year.

The couple and their daughter, Geneva, relocated from Annapolis, Md., about nine months ago and are now full-time residents of Cape Charles.

Their business venture has been in the works for nearly three years, around the time they bought their home on Nectarine Street.

Cape Charles was one of the top results Katie Austin got several years ago when she went online to search for a “historic affordable beach town.”

Like many others before them, the Austins visited Cape Charles, fell in love, and bought a home there.

Almost immediately after purchasing their home, they got the idea to bring mini golf to town.

Their vision was to build something with a “quaint, charming appeal that blended in with the character of the town,” Katie Austin said.

Before the miniature golf course could be built, the Austins had to go through a complex, two-and-half-year process that included getting no fewer than four approvals.

The detailed project plans had to get the OK from the Cape Charles planning commission, zoning administrator, historic review board, and Town Council.

Not wanting to model Cape Charles after larger-scale beach tourist towns like Virginia Beach and Ocean City, Md., some board members were skeptical initially, but they all were “great to work with,” Austin said.

Public reaction also was “mixed” at first, but as the plan progressed, people became “excited” to see it come to fruition, she said.

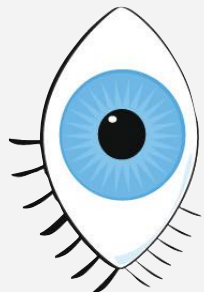
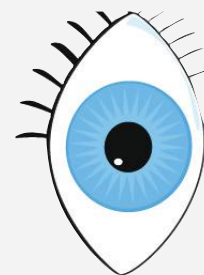
