## Samuel Cooper, circuit clerk, sets retirement

Has directed court since 1983: 'You're constantly learning'

When Samuel H. Cooper Jr. started his career, he planned to be a funeral service provider.

More than 40 years later, he is retiring after four decades of service as Accomack County's Clerk of Circuit Court.

"It's been a wonderful ride," said Cooper, who recently announced his retirement from the role he began in 1983.

"I've never had a day that I've dreaded coming to work," he said of his career.

A licensed funeral service provider, Cooper's career in the office on the Accomack courthouse green began in a funeral home.

Clifton Humbles, owner and operator of C.C. Humbles Funeral Service, where Cooper was working at age 27, was reading the newspaper one morning and saw the can-

## New library is complete; lease isn't

County, library board haggle as move-in date straggles

A new regional library building is ready for occupation, but the timeline to move in and open the facility in Parksley remains unknown.

Accomack County, which owns the facility, and the Eastern Shore Public Library Board of Trustees haven't agreed to lease conditions for the building.

A lease must be signed before the library system begins the move to the new building on Bennett Street.

"We're working on getting in as soon as we can and we're looking forward to it," Board of Trustees Chair Joyce Holland said Monday, June 5.

"We anticipate to be in within the next couple of months," she said.

Accomack County issued a certificate

## Man in highway fatally injured when hit by car

A New Jersey man was fatally injured when he was run over by an automobile in Mappsville while walking in the lane of travel.

Jonathan Morales, 32, of Jersey City, N.J., was walking in the north-bound lane of U.S. Route 13 on Saturday, June 3, at 9:37 p.m., when he was hit, said Virginia State Police spokeswoman Michelle Anaya.

Morales was wearing all black cloth-

ing, she said.

The crash occurred near Kegotank Elementary School.

He was struck by a Honda Ridgeline driven by Wilson Shannon Darrell Davis, of Wilmington, Del.

Morales died at the scene, Anaya said.

"No charges have been placed at this time," said Anaya.

It is unknown if alcohol was a factor.

of occupancy for the new library building March 20, but the library delayed move-in after the Eastern Shore Public Library Foundation and ESPL board sent a letter to the county April 15 citing several concerns with the draft lease agreement.

Among them was the fear the lease could adversely affect a 2018 memorandum of understanding between Accomack County, the library board, and the library foundation because the lease is only between two groups: the library board of trustees and Accomack County.

During a presentation to the Accomack Board of Supervisors on April 19, County Administrator Mike Mason said the lease does not nullify the memorandum, even though it is only between two groups.

Another issue the letter flagged is that lease terms suggest Accomack County could borrow money against the library's equity.

Mason said the library board would have to agree were the county to borrow money against the library's equity.

During his presentation, he said the county does not have "nefarious" intentions regarding

the library. He noted the county borrowed more than \$2 million for library construction and appropriated an additional \$223,000 in federal American Rescue Plan Act funds to address roof issues that arose during construction.

"There are, combined, thousands of hours spent on this project," he said.

According to the lease, the library board will rent the new library for \$1 total through June 1, 2039 — the maturity date of the bonds issued by the county to pay for the library's construction.

The library property will be conveyed to the library board at the end of the lease, according to the terms.

The library board is responsible for the cost of all utilities and services, while Accomack County will insure the building and will maintain and repair the building, equipment, grounds, and parking lot on a reimbursement basis.

The board is responsible for insuring the contents of the library, which also includes the Heritage Center, a repository for archival documents and other items related to Eastern Shore history.

The Accomack Board of Supervisors approved the lease at its meeting April 19.

After the library board of trustees signs the lease, move-in can begin.

"The move itself will take a little time," Holland said. She said it will take a professional moving company about two to four weeks to complete the move.

The new Eastern Shore of Virginia Regional Library and Heritage Center in Parksley will replace the 11,000-square-foot regional library in Accomack, which dates to 1965.

New amenities will include a large community meeting room; separate, small rooms for meetings or group study; more space for public computer use; and a maker's space where people can work together on projects.

Ground was broken on the 20,837-square-foot building in 2019, though the project began conceptually over a decade ago.

In addition to \$1.5 million from the state, Accomack County contributed \$2 million to the project. The Eastern Shore Public Library Foundation raised \$1.5 million through fundraisers, capital campaigns, grants, and a loan.

"All parties are working hard and ... library staff are super excited for the move and looking forward to it," said new ESPL System Director Miranda Wisor.

"The new building is ready for occupation now pending the execution of the lease," Mason said.

The new library site is 24313 Bennett St., at the former Fresh Pride grocery store, in Parksley.



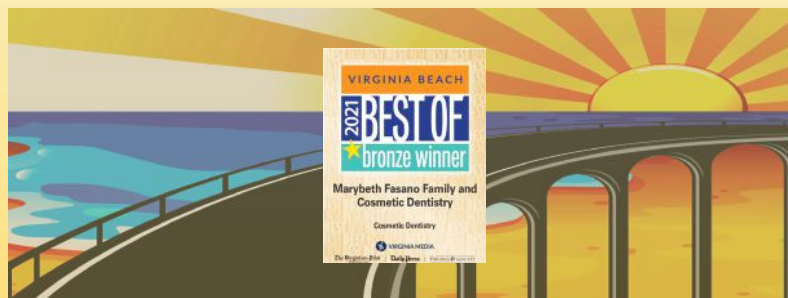

# Accused double-murderer sent to psychiatric hospital

An accused double-murderer in Accomack County has been sent to a psychiatric hospital in an attempt to restore him to competency to stand trial.

In a hearing to review the case of Gary Fleig, 47, of New Church, Commonwealth's Attorney Spencer Morgan told the court the psychiatrist who was treating Fleig said the accused man was still not competent to stand trial.

He recommended continuing a jail-based program to restore him to competency.

Fleig is charged with first-degree

murder, arson, and burglary in the death of 62-year-old carpenter and musician Edward B. Mears Jr. of Oak Hall on Dec. 4, 2021.

He is also charged with the murder of 44-year old Maurice Lamont "Rico" Fidderman two days later.

Morgan said he thought it would be more effective for Fleig to have in-patient treatment and asked that he be taken to Central State Hospital in Williamsburg to receive care needed to restore him to competency.

Judge W. Revell Lewis III said he agreed with Morgan and ordered that Fleig be taken there for his treatment.

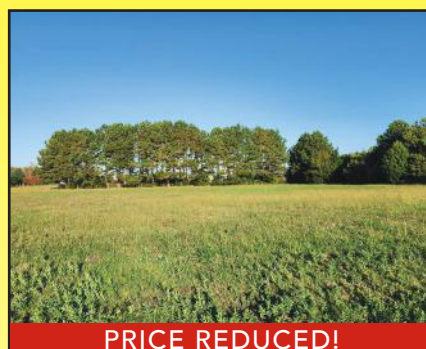

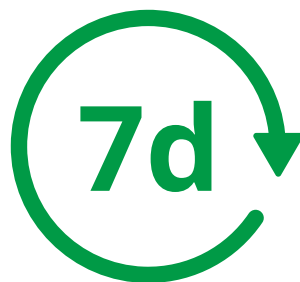

# Our eyes have a mist from the smoke of a distant fire

If you're a 1970s rock 'n' roll fan, you may be finding yourself humming a song that is atmospherically apropos.

The lyrics from the Sanford-Townsend Band's 1977 song rang true this week: "Your eyes had a mist from the smoke of a distant fire."

In our case, the smoke came from more than 400 active fires burning hundreds of miles away in Canada. And the mist was our watery eyes battling the dirty air.

As more than 150 wildfires burn in the Quebec province alone, we're reminded how inexorably we are linked with our neighbors, even on a global scale.

Seasonal wildfires are normal to a degree, but outbreaks on such a sweeping scale are exceptional and tied to regional droughts and above-normal temperatures.

A storm system swirling off the coast of Nova Scotia brought the problem home to residents of the Eastern Shore on Wednesday morning, as it forced the smoke and red-level air quality warnings south along the United States' East Coast.

The sepia skies are expected to continue for a few days. Health officials advise residents — and their pets — to limit time outdoors and keep windows closed until the air quality improves.

Other advice includes wearing a mask outdoors and using an air purifier, if available. Officials also recommend checking sites such as [airnow.gov](https://airnow.gov) for the latest air quality reports, though the site lacks data specific to most Eastern Shore towns.

Whether it is our regional fisheries or air we breathe, impacts in one area often have far-reaching impacts.

So stay indoors if the smoke-filled air affects you. Perhaps use the time to catch up on more great 1970s music from the long-lost Sanford-Townsend Band.

Wallops Navy Death Toll.”

The column reflects on those Navy personnel that lost their lives in air mishaps around the Wallops Naval Base.

My father, Irving Austin, who passed away in 2021 at the age of 99, worked as a civilian laborer at the then Wallops Naval Air Station.

Among some of his duties as a civilian laborer was to load and unload cargo, including live ammunition, from planes.

He would share with me, growing up, about the many plane crashes that occurred at and around the naval base especially during the early 1940s.

Many of these mishaps would occur during training exercises as pilots prepared for entry into combat during World War II.

One such crash that he remem-

bered was the one that occurred on May 20, 1943, which you listed in your article.

My father knew those two pilots, last names of Hutt and Wells, who perished in the crash.

As a civilian laborer, he had the opportunity to meet some pilots while at the air station. He would talk about how friendly these men were and Dad never forgot them or their names for the rest of his life.

He even shared that their plane, a two-seat aircraft, crashed in a wooded area located behind the current transfer station in Horn-town off of what is now Fleming Road.

Reading the column brought back memories of what my father had shared with me about his experiences at the Wallops Naval Air Station. Thank you for writing this column.

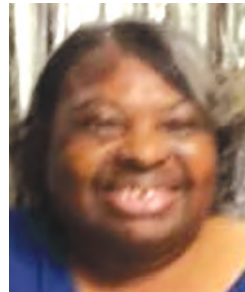

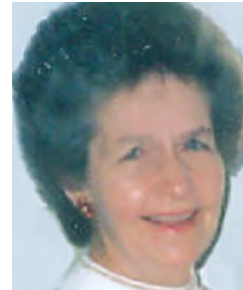

## County OK's proposal for senior housing initiative

The Accomack County Board of Supervisors approved rezoning 11.5 acres on Hermitage Road from Agricultural District to Village Development District following a public hearing last month.

It is the first of several steps needed before MCAP Eastern Shore Land LLC can build a proposed 40-unit senior housing development on the property across Hermitage Road from the existing Commonwealth Senior Living center outside Onancock.

"This is simply rezoning the property. This is not approving the project," board Chair Robert Crockett said.

MCAP Eastern Shore Land must still obtain a conditional use permit, which involves two more public hearings by the Accomack County Planning Commission and the Board of Supervisors, said Deputy County Administrator Lee Pambid. The company will submit a more detailed concept plan during that process, he said.

Accomack's planning commission recommended approving the rezoning request and held a public hearing on the proposed change earlier this spring.

Several members of the public expressed concerns about issues such as re-sale terms for the senior housing facility and age requirements for residents there during the public hearing.

"Those questions will be answered and responded to in the next process," Crockett said.

### VDOT plan

The Board of Supervisors approved the Virginia Department of Transportation's Six-Year Plan for Secondary Roads during its meeting last month.

The plan for Accomack County provides \$617,025 from 2024 to 2029 — "roughly \$100,000 per year, which doesn't allow a whole lot of VDOT improvements to happen on the Shore," said County Administrator Mike Mason.

The active project list was reduced to include only priority projects that can be funded and constructed, said VDOT's Accomack Residency Administrator Chris Isdell during an April meeting.

The top-priority project in the plan is Lee Street in Belle Haven, which is fully funded at a cost of just over \$6 million and is set to be completed in November.

# At Exmore Council meeting, a sewage issue hits the fan

An Exmore resident threatened to sue the town and turned his nose up at the explanation of why town officials could not solve his sewage problem.

Emily and Scott Hines told the Exmore Town Council on Monday, June 5, that the drainfields of their neighbors' septic system had failed, causing sewage to flow into their driveway at their home on Main Street.

The problem had persisted for more than five weeks without a resolution.

The family turned to the town for help, but there was little Exmore officials could do.

Director of Utilities Taylor Dukes had contacted the local health department about the "river" of wastewater being pumped from the residence, spilling over onto the Hines property.

The health department issued a notice of violation, yet it could impose neither a fine nor a deadline for the neighbor to fix the problem.

In the past, a notice of violation gave the recipient 30 days to correct the issue, but that 30-day time limit had been removed at the state level, Dukes said.

The old house was built over its septic tank and the entire situation was a "nightmare," he said.

Dukes said he and Police Chief Angelo DiMartino had combed through Exmore's code of ordinances and found that a resident could be fined \$25 a day for the polluting offense.

The town attorney recommended increasing the daily fine to \$150 or \$250 to make a bigger impact on the offending property owner.

Dukes has considered every additional course of action but said none is viable.

The offending residence was built before Northampton County began

issuing certificates of occupancy, so there is no certificate that could be withdrawn.

Neither can Northampton County condemn the building, and the health department cannot require the residents to abandon their home.

"The frustration is it's not an Exmore problem, it's a health department problem, and they're washing their hands of it," said Town Manager Robert Duer.

Exmore officials speculated that the neighbors' septic system may have been backed up with grease from the food truck they keep parked in front of their house, causing the drain fields to fail.

The fire marshal had closed the food truck due to safety issues, but the food truck was set to reopen soon.

Scott Hines said he did not oppose the food truck, only the dumping of sewage.

His mother, Theresa Adams, asked DiMartino if she could dump the sewage from her motor home onto a public street without legal consequences.

Duer said the problem is that the Virginia Department of Health has been stripped of its power to act.

Scott Hines thanked Exmore officials for their attention but said he spoke to an attorney who advised him to sue his neighbor, the town, and the health department for negligence.

"Well, that's the end of the conversation then," Duer said. "We hear you. Thank you."

In other news, town officials noted Exmore needs an ordinance preventing food trucks from remaining parked on the street 24 hours a day, seven days a week.

Duer suggested the ordinance should be similar to a Cape Charles ordinance that requires food trucks to be moved off the street at night.

# Beebe Ranch fund drive nears goal

When the Museum of Chincoteague Island announced a fundraiser to purchase and preserve the Beebe Ranch, thousands answered its call.

The museum is close to its \$625,000 goal to save the ranch, which was Misty of Chincoteague's longtime home.

Donors have contributed over \$525,000 toward the goal, which the museum hopes to meet before closing on the property June 30, said Cindy Faith, executive director of the Museum of Chincoteague Island.

"This has been the best experience of my career," Faith said of the grassroots effort to save the ranch on Ridge Road. "It's just incredible to be a part of it."

The Beebe Ranch dates back 100

years, when Clarence and Ida Beebe — known to most as Grandpa and Grandma Beebe — owned over 100 acres of pastureland on the island's south side.

"He became somebody on the island that everyone respected as far as his knowledge of the ponies," Faith said of Grandpa Beebe.

That led Marguerite Henry to his ranch in 1946, when she visited Chincoteague to collect stories for a book about the island's annual pony auction.

Henry published "Misty of Chincoteague" the next year, inspired by its namesake pony born on the Beebe Ranch.

Following the novel and the premiere of the "Misty" movie in 1961, the Beebe Ranch became a museum of sorts, hosting visitors to see Misty's

stall and the Beebe family home where, during the Ash Wednesday Storm of 1962, the family took a pregnant Misty up the front steps and into the kitchen to shelter her from the storm.

The story inspired Henry's 1963 novel, "Stormy, Misty's Foal."

Over time, the ranch dissolved as Grandma and Grandpa Beebe's children sold their portions of the property. Billy and Barbara Beebe own the remaining 10.3 acres, but recently made the decision to sell the ranch.

"It is not an active farm anymore and it is a big parcel to take care of," Faith said.

Since announcing the fundraiser to purchase the ranch almost 12 weeks ago, the museum has received a "whirlwind" of support, she said.

In addition to thousands of donors, supporters from across the country have raised funds through racing competitions, Etsy sales, and items donated to the museum for auctions.

This week, local philanthropist David Landsberger gave the museum \$100,000 as part of a matching fundraiser challenge.

"It's obvious from the response that there are just people from all around the country that are grateful to have read the book or have been to Chincoteague," Faith said. "There are all kinds of reasons people are helping us."

The museum is still developing plans for the future of the Beebe Ranch, which could include hosting

school groups, Road Scholars, and other programs, she said.

The group will work to raise funds to rebuild the barn that burned down in 2019, but has no other plans to add structures to the property, Faith added.

"People came out of the woodwork to help and every donation has been just wonderful to receive," Faith said.

"We're just grateful," she said.

Supporters have a chance to support the "Save the Beebe Ranch" effort with a buy-back foal during an online auction starting this Friday, June 9, and ending Wednesday, June 14.

Buy-back foals are part of the Chincoteague Pony herds and are released back onto the island with the wild ponies.

## Bridges wins first in Shore Girls Flounder Tournament

The recent improvement in angling activity directly corresponded with the long-awaited wind directional switch.

The old saying, “Wind from the east, fish bite the least,” has a lot of truth to it, especially when it comes to flounder fishing.

### Upper Shore

The Sea Hawk Sports Center reported that the silver lining from the recent run of easterly winds, unseasonably cool temperatures, and rainy conditions has been the lack of biting insects. But I have a feeling that is going to change soon when we get that first big mosquito to hatch of the year. Captain Matt Abell and the gang still highlight the fishing in the shallows of the Pocomoke and Tangier Sounds, wherever you can find shelter from the wind. Chunks of peeler or soft crab fished on a scaled-down fish-finder rig or a double-hook top and bottom rig are producing red drum, speckled trout, rockfish, and an increasing number of cow-nosed and stingrays. Where clear water can be found, casters have enjoyed success with Mirrolures and paddletails. The best action has been occurring when the tide has been running. Bluefish and black drum have come from some of the deeper waters in the sounds, particularly around submerged structures and over hard bottom.

On the seaside the east winds have impacted the flounder fish-

ing, as catch numbers and sizes have diminished with the murky conditions. Most of the recent catches have been made on Berkley Gulp Swimming Mullet or Gulp Shrimp, tipped with either a silverside or live minnow.

### Wachapreague

Amanda Estrada-Ramos, at the Wachapreague Inn, reported that the Shore Girls Flounder Tournament was held on June 2-3, with 15 registered boats bringing in 26 flounder to the scales. In spite of the dense fog on Saturday, a nice mix of undersized and legal-sized flatfish were landed in the 70-degree water. Angler April Bridges captured first place in the tournament with a 20.5-inch flounder. Her catch was worth \$870.75. Bridges was part of Team Almost Persuaded with Captain Lindsay Paul. The team won a total of \$1,680.00 in prize money for their efforts. The tournament raised \$1,656.00 for the charity “Dogs Deserve Better Eastern Shore, VA.” Most of the keeper-sized fish were found near the inlet. The fishing vessel Glaucus enjoyed another successful run to the offshore wrecks over the week, landing a limit of black sea bass and some bluefish.

### Lower Shore

Jeb Brady, at Bailey’s Bait & Tackle, commented that the weather continues to be the biggest influence of angling success. Anglers seeking trophy-sized red drum have enjoyed success on Nautilus Shoal and in the surf of Fisherman Island, using cut crab for bait. Cobia have been caught and released by anglers chumming and fishing cut baits, as recent weather conditions have not been ideal for sight casting. The waters around the fourth island of

the Chesapeake Bay Bridge-Tunnel have produced some small black drum and sheepshead. Brady said that the flounder fishing has been tough with the east winds. The lower bayside shorelines have produced speckled trout catches for anglers casting topwater and soft plastic baits. John Elliott released a 27-inch speckled trout and kept a trout weighing 6 pounds, 6 ounces. Small croaker and gray trout catches have come from the Cape Charles and Kiptopeke State Park Piers.

Dan Bell, at Oceans East-Eastern Shore, also said that the weather has been responsible for a slow start to the

spring season, but the angling activity is finally starting to pick up. Bell said that cobia are being spotted cruising the surface, while the recent improvement in the weather has helped the flounder fishermen along the ditch and the high rise. The shop weighed in a flounder weighing 6 pounds, 6 ounces. Anglers casting Gotcha Plugs and weighted spoons have hooked up with bluefish near the fourth island. The late afternoon red drum bite was described as “very good” on 9-Foot Shoal and near the fourth island. Sheepshead numbers are improving

around the bridge-tunnel pilings, while croaker and sand mullet (whiting) are biting around the concrete ships. Black sea bass catches have come from the Triangle wrecks and the Light Tower.

# Onancock seeks funding to renovate former drug store

Onancock will apply for a \$600,000 Industrial Revitalization Fund loan to renovate the former Wise's Drug Store building at 51 Market St.

The IRF is a Virginia Department of Housing and Community Development program to redevelop vacant and deteriorated industrial and commercial properties.

The proposed mixed use for the building on the corner of Market and North streets would include businesses and allow housing, if DHCD awards the loan.

The low-interest loan would pass through the Town of Onancock Economic Development Authority, pending its creation, to Stephanie and Jim Selckman, who will also spend private investor funds on the revitalization project.

"We alone as a town can't loan to a private entity, so we created an Eco-

nomic Development Authority," Onancock's Town Manager Matt Spuck said of the proposed political subdivision during the town council meeting last week.

"There's no match requirement (and) no cost to the town," for the IRF loan, Spuck said. "Generally speaking, this is a money maker for the town because we get to keep the interest that we receive on the loan and any earnings on the funds as they sit in our savings account."

If DHCD awards the loan, Onancock will administer the grant and keep repaid loan money for future revolving loan funds, according to the resolution the town council passed May 22.

As part of the deal, the town council is considering creating an Economic Development Authority.

The council will hold a public hearing June 26 to vote on whether to create the Economic Development Authority of the Town of Onancock.

"The purpose of the EDA is to pro-

cess the transactions or economic development that can't legally be done by the town. Loaning money is one of them," Spuck said.

The proposed EDA is a "very fast and completely inexpensive way" to address a challenge posed by the town's application for DHCD funds to revitalize the former Wise's Drug Store.

"DHCD released these funds with-

out realizing that a municipality can't lend money," he said of the \$600,000 IRF application the town council approved last month.

"If we were to get money from the grant we just talked about, those funds would go into the EDA, then the EDA would write the check to the developer, and then they would repay the loans to the EDA," Spuck said.

didates running for circuit court clerk.

“His question to the four of us was ... ‘Which one of these candidates do you think would hire people of color?’” Cooper said.

“He said, ‘This would probably be an opportune time for someone of color to run for the office and ... the person is sitting right here at this table.’”

Initially laughing at the prospect of running for the elected position, Cooper won by 47 votes. He has won the five elections since and will have served 40 years in the role in December.

He was the first Black employee not only to serve as the circuit court clerk in Accomack County, but also in the clerk’s office.

Cooper’s election was the first time a Black candidate on the Eastern Shore had been elected to a position required by the state constitution.

He started the job with the skills to look up a deed, so Cooper took a three-day trip to Charlottesville after winning the election to learn more about the duties of a circuit court clerk.

“Realistically, I was more confused after I left than when I got there,” he said. “You can’t pick up a textbook that says ‘Clerk of Court 101.’”

He attributes part of his early success in the position to inheriting “a good staff.”

Cooper laughed that he is still tackling the learning curve — and said that is part of what kept him in his role for 40 years.

“You’re constantly learning,” he said. “There are days that I can come into this office and I feel confident there’s nothing you can ask me that I can’t address, then that’s the very day that you come up with something that I’ve never heard of in my life.”

Sometimes, the requests have nothing to do with circuit court records.

He recalled one instance when a dialysis patient called Cooper’s office upset because a doctor had changed the time of her appointment.

He called the medical center to explain the situation and assisted in moving the appointment back.

“You don’t really know what to expect from one day to the next ... but

it’s been a very, very wonderful experience,” Cooper said.

“The most rewarding part is the fact that you earn people’s trust and you earn their confidence.”

He credits his family with supporting his career, recounting a time when, as president of the Virginia Court Clerks Association, he was arranging an annual convention on Chincoteague Island with the help of his wife, Sandra Cooper.

“Sandy and myself were soliciting door prizes from the businesses on Chincoteague and, if we went in to 10 businesses, eight of them knew her but didn’t know me,” he said.

His son, Cedrick L. Cooper Sr., an

accountant, plans to run for Accomack’s Clerk of Circuit Court position in the upcoming election, he said.

Cooper’s advice to his successor is to approach the role with compassion.

“What’s not important to you can be the epitome of importance to someone else,” he said. “This position can be a counseling session ... as much as an administrative position.”

He said he does not have specific plans following his retirement, but will be more active in his Cooper & Humbles Funeral Company, which his daughter, Shenae, manages.

His decision to retire, Cooper said, is to bring “new blood” to the role he

served for 40 years.

His hopes are for his replacement “to be open-minded to technology and innovations related to this office, and to do what you can to keep your employees happy.”

“I hope they can have a third of the enjoyment that I’ve had,” he added. “It’s been very rewarding in the fact that over the years, I have earned the respect of many residents.”

“It’s a humbling feeling when people have that much confidence in you.”

Cooper’s last day as Accomack County’s Clerk of Circuit Court will be Dec. 31, though he said he will be “in and out” of the office to assist his successor.

# Eastern Shore Waste Watchers gets state grant

Funds awarded for Green Grants will be used for its “Help Keep the Shore Litter-Free” program, which strives to support a cleaner, healthier Eastern Shore. The money will purchase supplies needed for safe litter cleanups, such as safety vests, litter grabbers, gloves, and hand sanitizer.

The mission at Keep Virginia Beautiful is to engage and unite Virgin-

ians to improve the natural and scenic environment. Since 2011, the Green Grants Program has provided \$282,000 for 385 programs and projects throughout the state. Funding is made possible through generous support from Altria, as well as additional sponsorships from WestRock and Village Bank.

## Cape Charles Christmas ornament is available

Since 2019, Cape Charles Main Street has released an annual Christmas ornament of an iconic structure in Cape Charles to celebrate the town’s historic and coastal character.

These ornaments are created by the same company that makes ornaments for The White House. They come beautifully gift boxed with descriptive cards telling the story of each memorable structure.

Its first series, a limited-edition ornament of the water tower, was so popular it sold out. The group then went

on to release an ornament each year, including The Love Sign, Kelly’s Ginnut Pub, Bailey’s Bait and Tackle, and Peach Street Books.

The 2023 ornament is the Wilson Building. It first was a two-story building that held a dry goods store owned by L. E. Mumford. In 1894, W. B. Wilson bought the store from Mumford and opened Wilson’s Department Store. Wilson added two more floors to the building in 1916 and it became the largest department store in the area.

Later, Peebles Department Store was located there and then the building was left vacant for some time. Painted advertising for Wilson’s Department Store is still visible on the left side and rear of the building.

Gordon Campbell bought the building, located at 245 Mason Avenue, renovated it, and opened At Altitude Gallery in 2015. Today, the upper floors are condominiums.

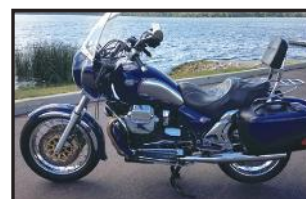

Virginia’s small grains outlook is favorable

Peaceful plots of waving grains are ground zero for intensive research and development that keeps Virginia farmers competitive.

Stakeholders took the opportunity to see it for themselves at the recent 2023 Virginia Small Grains Field Day at the Eastern Virginia Agricultural Research and Extension Center in Richmond County.

The event was presented by AREC faculty, staff of Virginia Tech’s College of Agriculture and Life Sciences and the small grains breeding and genetics program in Virginia Tech’s School of Plant and Environmental Sciences.

Dozens of seed reps, researchers, growers and grain marketers toured research plots across the AREC’s 215 acres of cropland. Plot trials at experiment stations help evaluate the newest small grain varieties, fertilizers and crop protectants, said Josey Moore,

Virginia Farm Bureau grain marketing specialist.

“This AREC tests out a lot of products for people in small experimental plots,” she said. “And we like to come see what’s doing well in this climate and soil.”

The event also was sponsored by the Virginia Grain Producers Association.

Nicholas Santantonio leads the Virginia Tech small grains breeding program research team. During the field day, he discussed wheat and barley variety development.

A collection of dense genetic data helped his team identify and enhance desirable traits in small grain varieties, resulting in increased yield, quality and disease resistance. While about 8 million bushels of wheat are expected to be harvested in Virginia this year, mildew and leaf rust have been somewhat troublesome statewide.

However, there’s a renewed interest in barley since the craft beer industry has boomed, driving a demand for malt, Santantonio added.
