School project contract inked for \$81 million

Supervisors approve award with no real-estate tax increase

Northampton County supervisors on Wednesday, Nov. 15, unanimously voted to award a contract for \$81.3 million for the Northampton middle and high school improvement project.

"I want to start with really good news ... there is not a scheduled real estate tax increase or any additional debt required in order to do this project," said Finance Director John Chandler.

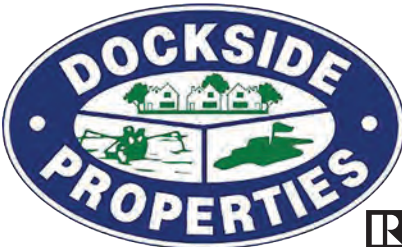
The Wednesday night decision was the culmination of a five-year effort by a committee that included members of both Northampton's board of supervisors and school board.

The effort hit a wall in August 2022 when the low bid received for the project was \$84 million, and county supervisors had agreed to spend no more

Man gets prison time in repeated assaults of woman

An Accomack County man was sentenced to four years in prison after pleading guilty to stabbing a woman with a screwdriver, punching her in the jaw, and urinating on her.

Christopher Ryan Collison, 35, of Keller, also was ordered to pay \$8,722 in restitution to the woman for moving and other expenses she incurred as a result of his violence.

In an earlier agreement with the prosecutor's office, Collison pleaded guilty to unlawful wounding and two counts of assault and battery.

Assistant Commonwealth's Attorney Fox told the court he made the agreement because the woman said she could not bear to see Collison again and could not come to court to testify.

The plea agreement capped his active sentence at four years.

At a sentencing hearing Fox read a lengthy and detailed letter to the court written by a woman who was violently assaulted by the defendant on nine separate occasions. Her name is being withheld by the Eastern Shore Post.

The woman detailed both the physical and emotional scars that remained from her relationship with Collison.

She described the physical injuries she suffered and said she is still suffering from the effects of his violent attacks.

She wrote she feared Collison would also assault her son. She said he never did, but threatened repeatedly to harm him.

The crimes occurred in June 2020, Fox said at Collison's September trial.

When the woman went to the emergency room as the result of an attack in late June, she reported multiple earlier assaults by Collison.

On one occasion, she said he came to her house when she was sleeping and pulled her by her feet off the bed onto the floor.

She said he caused her to hit her head on the corner of a nightstand, causing it to bleed profusely.

While she was on the floor, she said he kicked her repeatedly. On another occasion, he punched her in the jaw, knocked her to the floor, and began kicking her.

Another time, he stabbed her with a screwdriver, said Fox.

She said he held her against her will and that he sometimes urinated on her.

The woman reported suffering chronic pain from the beatings and said her son is now afraid of men.

She said she had to move from her home to get away from Collison. She said she suffers from post-traumatic stress disorder as a result of the beatings and takes multiple medications.

After listening to the woman's statement of what she suffered, Judge W. Revell Lewis III ordered Collison to spend four years in prison and to pay restitution in the amount of \$8,722.

He also ordered that a protective order be in place to keep him from having any contact with her.

Collison will be on probation for five years and required to be on good behavior for 10 years after his release.

Lack of concession calls indicative of our times

There is a long history in our country of the losing candidates in an election telephoning to concede and congratulate the winning candidates.

It is a courteous and gracious gesture — a sign that an election's sharp edges and spirited emotions have yielded to acts more civil and dignified.

After elections big and small, calling to concede and congratulate is a way of mending and moving on. It is a classy and cultured response to defeat.

To publicly concede — as candidates for high offices sometimes do — is a way to reunite communities divided by an election and its result.

Unfortunately, what is courteous and gracious is sometimes absent in the wake of elections these days — both nationally and locally.

At this writing, more than a week after many contested Nov. 7 elections, there have been far fewer concession calls than we expected from losing candidates to winning candidates.

There may have been more, but we know of one for certain — Accomack Supervisor Harrison Phillips called to congratulate supervisor-elect Calvin L. Washington Sr., and to concede. That's a respectable, humble, and admirable response from a dedicated public servant like Phillips.

Other winning candidates have said, off the record, that they have heard nothing from the opponents who lost in elections.

That's unfortunate. We hope this editorial reminds them of the importance of such an action. And we hope they soon reach out with a message of concession and congratulation.

Virginia Farm Bureau annual convention in Va. Beach

Virginia Farm Bureau Federation's 2023 Annual Convention and Meeting of Voting Delegates will be held Nov. 27-29 at the Virginia Beach Convention Center. Its theme is "Navigating Agriculture's Future."

Jason Brown, a former NFL player and current owner of First Fruits Farm, will deliver keynote remarks at the Nov. 28 Farm to Table Luncheon.

Brown chose to pursue community service through agriculture after his departure from the NFL, purchasing a 1,000-acre farm in Louisburg, N.C., in 2012. The farm has since yielded 1 million pounds of produce for area food pantries and churches.

American Farm Bureau Federation President Zippy Duvall will address the Annual Meeting of Voting Delegates about national Farm Bureau policies on Nov. 29.

Duvall, who farms in Georgia, helped shape the 2018 Farm Bill and is working to ensure the 2023 Farm Bill effectively supports farmers and ranchers.

Keighley Gore, the 2023 VFBF Distinguished Farm Bureau Woman, will speak during the Nov. 29 Fellowship Luncheon.

Through her work with the Frederick County Farm Bureau Women's Committee, Gore has been integral in advocating for agricultural education. She serves on the Frederick County Public Schools Agriculture Advisory Board, as well as the Virginia FFA Foundation board.

Three educational sessions have been planned for Nov. 28:

- **Nontraditional Succession in Family Farm Business:** presented by Dick Wittman of Wittman Consulting.
- **Courts & Ports: A Look at Legal & Economic Issues Facing American Agriculture,** led by AFBF Deputy General Counsel Travis Cushman and AFBF Senior Economist Veronica Nigh.
- **Farm Equipment: Navigating Repairs and Emerging Technologies,** featuring representatives of AgCO, John Deere, Kubota, and New Holland.

During the Nov. 29 Annual Meeting of Voting Delegates, county Farm Bureau leaders will help shape VFBF state and federal policies for the coming year. Policies related to national issues will be submitted to the AFBF for consideration at that organization's annual convention in January.

Delegates also will take part in elections for five seats on the VFBF board of directors.

The lower Shore speckled trout population has started to depart for more southern waters, while the

puppy drum population continues to linger a little longer.

Striped bass are beginning to become the focus of most anglers and will continue through the end of the year.

Submerged structures from the mouth of the Chesapeake out several miles into the Atlantic continue to harbor gray triggerfish, black sea bass, and increasing numbers of tautog.

Upper Shore

Captain Matt Abell, at the Sea Hawk Sports Center, reported that his clients and guide service have witnessed an expected seasonal decline in the variety of species available to anglers in the Tangier and Pocomoke sounds; however, the quality of the remaining and arriving fish, primarily striped bass, continues to improve.

Rockfish are scattered from deep-water structures to shallow water creeks. Rapala Rap-10's and Opening Night-Assassins have been the most productive lures recently, with the Assassins rigged on 1/4 to 3/8-ounce jig heads. Matt said that the fish seemed to be most aggressive during the tidal periods on each side of low water, and fan casting to cover lots of water surface was the key to finding the striper schools.

Captain C.L. Marshall, of Tangier Sound Charters, called me on the way home from one of his early week charters to let me know that the striper fishing on the Choptank River is the best that it has been in many years. He

said that if the anglers are willing to travel up to the area, they are almost guaranteed to find schools of rockfish feeding under flocks of working birds, with catches of 50-plus fish almost commonplace.

A large number of the fish are measuring above the 31-inch maximum size slot limit. Marshall added that there is a tremendous amount of bait (bunker) in the area and the stripers are gorging themselves on the menhaden.

The most consistent action has been occurring over submerged structure in 3- to 8-foot depths, with Storm lures being one of the most productive artificial baits.

Chincoteague

Captain Steve's Bait and Tackle is hosting the shop's Annual Surf Fishing Tournament this weekend. The entry fee is \$25 and participants can sign up at www.stevesbaitandtackle.com or at the shop on 6527 Maddox Blvd., Chincoteague.

Prizes will be awarded for the heaviest catch in several species, including striped bass, red drum, black drum, bluefish, trout, and kingfish (whiting).

In addition, there will be prizes for the three heaviest fish overall: First place will earn a St. Croix Rod/Penn Reel combo. Second place receives a Star Rod/Penn Battle LE Combo, and third place gets a Tsunami Rod/Penn Fierce Combo.

The largest bluefish will earn a \$100 Captain Steve's gift certificate. All entered fish must meet Virginia Recreational Fishing regulations.

Fishing begins on Friday, Nov. 17 at 5 a.m. and runs through 5 p.m. Sunday, Nov. 19.

There will also be a potluck dinner on Saturday, Nov. 18 at the tackle shop for all registered participants. Call the shop at (757) 336-0569. Jimmy added that the shop has received a supply of fresh bunker and spot baits.

Wachapreague

Captain Lindsay Paul, aboard the charter vessel *Almost Persuaded*, told me that there has been very little angling activity out of Wachapreague over the last week.

Flounder numbers are on the decline, but there should still be a few fish around for the taking.

The offshore wrecks still support a good population of black sea bass and triggerfish, as well as increasing numbers of tautog.

Lower Shore

Jeb Brady, at Bailey's Bait & Tackle, described the puppy drum action as "decent" in the lower bay-side creeks and along the seaside marshes, with most of the fish being caught on soft plastics fished under popping corks.

The remaining population of speckled trout was described as "few and far between," but the fish that were caught hit on Mirrolures and soft plastics.

Schoolie-sized striped bass numbers continue to increase, with striper catches coming from the bayside creeks and around lit docks and piers after sundown.

Jeb remains hopeful that the population of larger-sized rockfish have begun their southerly migration from the northern portion of the Chesapeake Bay.

A few flounder catches are still being made off Kiptopeke and along the Chesapeake Bay Bridge-Tunnel.

The ocean wrecks continue to hold good populations of black sea bass and gray triggerfish.

Tautog catches should improve with the falling water temperatures.

Warriors, Yellow Jackets fall in state playoffs

The magic ran out for Nandua and Northampton last week in the first round of the state high school football playoffs.

Both teams had been off to slow starts this fall but found their groove in the final month and were playing well heading into the postseason. But both fell to higher seeded teams on the road: Northampton dropped a 27-22 decision at West Point, seeded third in Region 1A. And Nandua lost 20-6 at Poquoson, the top seed in Region 2A.

West Point 27, Northampton 22

Northampton (5-6), seeded sixth, almost pulled off the upset against a team that had beaten the Yellow Jackets 47-6 in September. Last Friday night, West Point (8-3) took advantage of two costly Northampton turnovers to take a 21-0 halftime lead.

But the Yellow Jackets roared back to go up 22-21 when quarterback Brock Leland scored on a 1-yard run with 8 minutes left in the game. But the host Pointers sealed the win when Jack Lewis ran in from the 1 with less than a minute left.

"It is a 48-minute game," said Northampton coach John Edney, "and we played like we were capable of playing in the second half, taking care of the football and communicating effectively on defense."

Leland finished with two rushing touchdowns, and Elijah Hope ran for 130 yards and a touchdown for the Yellow Jackets, while Tywone Sebastian caught three passes for 51 yards. Hope, Jerry Sturgis, and Joel Robinson were in on 10 tackles each for Northampton.

Edney said his team turned the season around after a 1-3 start by adhering to the old "one game at a time," improving incrementally but consistently each day. He praised his seniors for leading the way.

"This senior group embodied that ideology over the past several years," he said. "I have no doubt that they will continue on with that same effort and commitment to improvement in whatever chapter lies ahead of them in life, bringing them success. They are a great group of young men."

Poquoson 20, Nandua 6

The Warriors (5-6) saw a four-game winning streak come to an end against a Poquoson team with a strong running game. The host Islanders (8-3) went up 7-0 in

the first quarter, and Nandua looked like it would knot up the score early in the second when quarterback Isaac Stodghill hit Makai Dorn on a short touchdown pass. But the two-point conversion failed, and the Warriors trailed 7-6.

Poquoson stretched its lead to 17-6 on a field goal and touchdown in the second quarter, but the Warriors had a chance to make it close when Jai'mir Bailey intercepted a pass and returned it to the Poquoson 20 with less than a minute remaining in the first half. Three plays later, on a first-and-goal at the 5, Stodghill bobbled the snap, and Poquoson recovered the ball and ran out the clock.

It was as close as the Warriors would get the rest of the way, as they failed to drive past midfield in the second half. Poquoson added a third-quarter touchdown for the final score.

The Islanders held Nandua's normally strong running game in check, limiting the Warriors to 55 yards rushing. Stodghill threw for 113 yards and a

touchdown with one interception, and Eli Parker caught five passes for 56 yards. Defensively, Nazere Blake had 11 tackles and Dorn had 10, including two for losses.

"We knew they were going to be tough against the run," Stodghill said. "They definitely tackled well against powerful backs like Nazere and Makai. Our defense kept producing stops, but the offense couldn't get in the end zone as much as we should have. But we gave it our all."

"We made a lot of mistakes," added Blake. "But the season went really well."

Nandua coach Dennis McCall lauded his players for the way they fought back after losing five of their first six games, many of those a result of a rash of injuries.

"I want to credit the seniors," he said. "They could have laid down and quit (after that 1-5 start), but they didn't. We fought back, made the playoffs, went toe-to-toe with the number one team in the region, and with a few plays going our way, it could have been a different outcome."



Planners to consider short-term rental regs

Northampton supervisors are seeking to regulate short-term rental vacation homes, which some citizens say are negatively impacting their quality of life.

According to the proposal drafted by Northampton's planning commission, any new short-term rental will be allowed only by a minor special-use permit that will expire after five years.

A public hearing on the proposal will be held at the Northampton Planning Commission meeting on Tuesday, Nov. 21, at 6 p.m. Planners then will make a recommendation to supervisors on the proposal.

Short-term rental homes have been officially allowed in Northampton County by right – without a permit – since 2019.

Since then, the number of homes rented to tourists and other visitors has increased, as have the complaints from neighbors about nuisances such as noise and trash.

Requiring permits to operate short-term rental homes will pro-

vide a mechanism for enforcing their regulation.

The board of supervisors will be able to suspend, revoke, or cancel a permit if a short-term rental operator violates the conditions of the permit, fails to collect or remit transient occupancy taxes, or receives three or more substantiated complaints within a 12-month period.

The county will request that any short-term rental owner who is not a local resident provide the name and phone number of a "responsible person" who will be available to respond to complaints and correct issues at the short-term rental home within a "reasonable time."

short-term rental homes include:

Off-street parking at a short-term rental home must not detract from the character of the house or neighborhood.

Recreational vehicles, trailers, buses, or watercraft cannot be used as short-term rental homes.

A short-term rental stay must at least be overnight but may not last more than 30 days.

No more than three people per bedroom are permitted to stay in a short-term rental home.

Short-term rental homes must meet all applicable building codes, including those about carbon monoxide and smoke alarms, and the operator must include a five-year septic pump-out certification letter with the permit application.

In other news, a Portsmouth

property manager is applying to rezone two parcels totaling nearly six acres on the east side of U.S. Route 13, on Cedar Grove Drive and Seaside Road, near Kiptopeke. The planning commission also will consider the request on Tuesday evening.

The applicant, Curtis Raeford Eure, is acting on behalf of the property owner, Virginia Beach restaurateur Dimitri Hionis.

He is requesting the rezoning of a four-unit mobile home park and a piece of farmland, around three acres each, to a hamlet.

A hamlet is a neighborhood of single-family residences, not more than two per acre, that may also contain small-scale businesses, according to the Northampton County comprehensive plan.

Rezoning the land would allow a developer to build around 12 single-family homes on the property that was intended, in part, for agricultural use.

Abandoned Nassawadox hospital coming down

Five years after Riverside Shore Memorial Hospital relocated to Onancock, ideas of repurposing the old hospital building in Nassawadox have been abandoned and demolition is underway.

Heavy equipment arrived at the demolition site in October. Three outbuildings have been removed, but the main hospital building temporarily remains.

The demolition is expected to be complete in January 2024.

The building opened as Northampton-Accomack Memorial Hospital in 1970, which replaced the original 25-bed facility that had opened in 1928.

Northampton-Accomack Memorial Hospital was the Eastern Shore of Vir-

ginia's first hospital. Its history dates back to the 1910s, when the hospital auxiliary was founded and fundraising began.

Even though the old hospital building will not be reused, the land could serve a new purpose.

Northampton County received a \$70,000 grant from the Department of Housing and Urban Development Industrial Revitalization Fund, which was used to pay for a study of the 15-acre site by professional planners.

Possible plans for housing, including apartments, duplexes, triplexes, and senior cottages, were presented to Nassawadox residents at a public meeting in August.

However, Riverside has not offered the former hospital property for sale, and no formal plans for redevelopment have been made.

‘I think that folks were looking for a change’

After challengers knock off three longtime incumbents on the Board of Supervisors, many perspectives about voters’ desires

Voters in the Nov. 7 election ousted all challenged incumbent candidates running for the Accomack County Board of Supervisors.

The results might mirror a larger, nationwide trend in overall discontent with the political system.

“I think that folks were looking for a change,” said Calvin L. Washington Sr., who beat incumbent Harrison W. Phillips III by 67 votes, or 8%, for the District 5 board of supervisors seat.

He will represent Mappsville, Modest Town, Nelsonia, Gargatha, and Metompkin on the board starting in January.

Voters were “not feeling that they’ve been heard and not happy with the direction things are taking,” said Jeffrey A. Parks Sr., who beat incumbent Paul Muhly by 37 votes, or less than 4%, to win the

District 4 seat that represents Parksley, Bloxom, Saxis, and nearby areas.

Challenger Roger DeGeorges led longtime Supervisor Ron Wolff by 113 votes, or 9%, to become the new District 2 supervisor to represent Atlantic, Horntown, Greenbackville, and nearby areas.

He attributed his win to voters in Captains Cove, where he said discontent with real estate assessments and tax increases motivated residents to visit the polls.

A Pew Research Center survey released in Sep-

tember found that voter disillusion comes at the same time as historically high levels of voter turnout in national elections.

In Accomack County, over 45% of registered voters cast their ballots in last week’s election.

The Pew survey found only 4% of Americans believe the political system is functioning well or very well, and under one-quarter believe it operates somewhat adequately.

“When an incumbent has an opponent, that’s a real election and the voters have a voice,” said Muhly, who served two terms of four years each on the Accomack board of supervisors.

“The voters had a choice in three of the supervisors races and in (five) of the school board races, and that is how democracy is supposed to work,” he said.

“I think each race had its specific issues and reasons why some lost, some won, but all-in-all it was a healthy thing,” he said.

He, Wolff, and Phillips served a combined 36 years on the board of supervisors.

The supervisors-elect have several goals as they take on their elected official roles next year.

DeGeorges said addressing tax burdens and improving county schools will be priorities as he joins the board of supervisors.

Parks said his focus will be “to help make government work better,” including lowering tax burdens for residents.

Washington plans to learn more about the priorities in his district as he takes on the role of supervisor.

“I’m one of those who believe in being proactive rather than reactive and I hope that we’ll start being proactive in our community,” he said.

"I am very excited to be able to have that opportunity to have a seat at the table and be a voice for the people in Accomack County," he said.

All unopposed incumbents won their board of supervisors seats in Accomack's Districts 1, 3, 6, 7, 8, and 9.

The new supervisors will begin serving on the board Jan. 1, 2024.

Town repeals food truck ban — but zoning issue remains

Food trucks could be back in business in Parksley, but the town’s only mobile food vendor remains closed.

The Parksley Town Council on Monday, Nov. 13, repealed a new town law that had effectively barred food trucks from doing business in town.

However, an attorney writing on behalf of Parksley said food trucks are not included in uses allowed in the Parksley Zoning Ordinance, regardless of that law — meaning Parksley’s food truck ordinance was moot anyway.

“This zoning ordinance, like many others, sets forth what is allowed in a given zone rather than what is prohibited,” Attorney André D. Wiggins said in an email Nov. 15.

“If one looks at the commercial section of the Parksley Zoning Ordinance, you will see the many allowed or permitted uses and related definitions. The operation of a food truck is not included among the many permitted uses,” Wiggins wrote.

Those violating the ordinance can face fines of up to \$250 and imprisonment in the county jail for up to 30 days for each day they break the town code.

Clemen Bastien and Theslet Benoir had not reopened Eben-Ezer Haitian Food Truck on Bennett Street as of Nov. 15, after they received a letter from Wiggins, writing on behalf of

Parksley, requesting they “cease operation immediately.”

The letter dated Nov. 1 came after the Parksley Town Council voted Oct. 11 to pass an ordinance limiting mobile food vendors to selling their fare in town only during special events such as festivals that the town council had approved or sponsored.

Even though council members repealed the ordinance after a month,

it had drawn a series of responses during its short time on the books.

“We’re very happy that the city council repealed the food truck ban,” said Institute for Justice Senior Attorney Justin Pearson, who with Litigation Fellow Dylan Moore sent Parksley officials a letter on Nov. 6 calling on them to repeal the food truck rules.

“They never should have passed

that food truck ban in the first place, and so repealing it doesn’t undo all the harm, but it’s a step in the right direction,” Pearson said.

“That is awesome news for the town, for the residents, and for the city council,” said Calherbe Monel, of Virginia Beach-based advocacy group Christians United for Haiti, who has been working with the owners of the Bennett Street food trailer.

He wrote a letter to Parksley Mayor Frank Russell Oct. 29 requesting a meeting to discuss “what went wrong here,” which they plan to hold this weekend.

Bastien and Benoir declined to comment on the repeal of Parksley’s food truck ordinance, but thanked those who have supported them.

“That letter scared them, and that’s a reasonable reaction,” Pearson said. “That letter would’ve scared anyone and it’s clear that that was the entire reason it was sent.”

He said the next steps in addressing Parksley’s relationship with food trucks will unfold with new action by the town.

“People are going to be watching them,” Institute for Justice’s Moore said.

Of the town issuing a business license to Eben-Ezer Haitian Food Truck when food trucks are not included in the zoning ordinance’s permitted uses, Wiggins said: “I am not in a position to answer that question.”

The business paid \$30 to Parksley for the business license on May 14, 2023.

than \$65 million.

About a year later, the project was resubmitted for contractor bids, but the lone bid received was not lower, but higher — almost \$99 million.

Since September, committee members have worked to reduce the cost of the project and scrape together more money.

The biggest cost reduction was in delaying the renovation of Northampton High School's career and technical education building, a savings of \$6 million.

About \$4 million was saved through value engineering — flexibility in the brands and types of materials and equipment used, saving money without sacrificing quality.

The entire project will cost about \$89.8 million, but some costs were excluded from the contract to be awarded to M.B. Kahn, of Columbia, S.C.

Among the excluded costs was nearly \$5.7 million for furniture, furnishings, and equipment, which will be purchased throughout the three phases of construction as funding becomes available.

Permits, fees, inspections, and other soft costs also were not included.

The \$89.8 million total project cost will be attained through the following funding sources:

- A \$50 million bond, or loan, that Northampton County previously acquired

- A \$16.8 million state grant from the School Construction Assistance Program

- About \$8 million from Northampton's undesignated fund balance or "rainy day" fund, which currently totals around \$15 million

- Nearly \$7.5 million expected to be added to the undesignated fund balance over the next five years

- Almost \$2.5 million from the Northampton schools capital fund

- About \$1.9 million in estimated future interest

- Around \$1.25 million in Virginia Department of Education school construction funding

- About \$1.1 million in anticipated future revenues from Northampton's 1% additional sales tax

- County funds of \$700,000 to extend Eastville's water line.

The project will include demolishing most of the original 1954 high school building, renovating the 1978 addition, and new construction.

When the project is complete, Northampton Middle School, which shares a campus and school building with Northampton High School, will have its own classroom wing, gym, and separate space in the cafeteria. The two schools will share an auditorium.

Before voting on the matter, some supervisors needed reassurance that their nearly \$90 million investment would be protected.

Supervisor Betsy Mapp said she was "shocked at the lack of maintenance" of older school buildings like the former Northampton Middle School in Machipongo.

Superintendent Lisa Martin noted that a Northampton County Public Schools maintenance plan and new capital improvement plan were forthcoming.

Director of Operations Chris Truckner pledged, "I'm not going to allow anything to happen on my watch" to interfere with school maintenance.

The push to renovate or rebuild Northampton High School began around 2007, when a structural study revealed that much of the building was in poor condition.

Once construction begins, the school improvement project will take about 30 months to complete.

Renovation of the CTE building has not been canceled but postponed until additional funding can be obtained.

Board of Supervisors Chairman John Coker conveyed the urgency to award the contract without further delay.

He said, "Pretty much everybody we could talk to that has done any kind of project like this, they're saying, 'Listen, sign it now ... because next year it's going to be \$3 to \$5 million more.'"

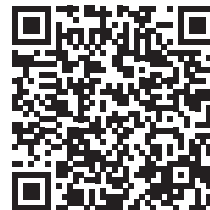

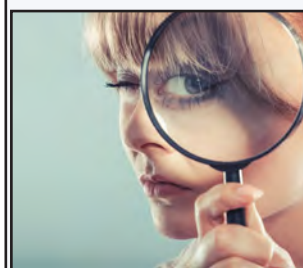

To amend and re-enact Ordinance No. 124, which passed June 20, 1994 entitled "An Ordinance to Supersede and Amend any Previous Ordinances Pertaining to Establish Charges and Conditions for Water Rates, Sewer and Trash Fees" to become effective July 1, 2024 with the following changes:

Section 1 is changed to read ...

"Water Fee: \$16.50 minimum up to the first thousand gallons and \$.25 cents per one thousand gallons from one thousand one (1001) gallons up to ten thousand gallons (10,000), and \$.45 cents per one thousand gallons from ten thousand one (10,001) gallons and up"

"Sewer Fee: \$40.00 Operation and Maintenance Fee per single family (housing) unit monthly

Plus \$8.00 per 1,000 gallons Effluent Treatment Fee monthly."

Sewer Fee for Households Without Town Water Meter:

\$40.00 base per month

\$12.00 per person living in household

Establish a Residential Flat Rate:

Single family residential customers using a significant amount of water not discharged into the sanitary sewer system (typically irrigation or swimming pools) can establish a flat rate account with the Town.

The Director of Utilities or Town Manager may approve a flat rate if the requester provides sufficient evidence that there is a significant amount of water not discharged into the sanitary sewer system relative to average residential water consumption.

Residential sanitary sewer system users who are not municipal water users will have a flat rate determined by the Utilities Director based on an estimated water usage by the home. Such residents are strongly encouraged to install water meters to ensure accurate usage, but where such cannot be accomplished a flat rate will be determined.

ORDINANCE NO. 228

AN ORDINANCE OF THE TOWN OF EXMORE TO AMEND AND SUPERSEDE ANY PREVIOUS ORDINANCES PERTAINING TO DOGS RUNNING AT LARGE

THE TOWN COUNCIL OF EXMORE, OF THE COUNTY OF NORTHAMPTON, COMMONWEALTH OF VIRGINIA, ORDAINS AS FOLLOWS:

WHEREAS, Ordinance No. 193 of the Town of Exmore provides for the imposition of fines for violations in the Town of Exmore for which punishment in the form of fines is prescribed; and

WHEREAS the schedule of fines in Ordinance No. 193 is out of date.

NOW, THEREFORE, be it ordained by Council of the Town of Exmore, Virginia that Ordinance No. 193 of the Town of Exmore is amended and replaced by Ordinance No. 228, on this date December 4, 2023, and is enacted as follows:

BE IT ORDAINED BY TOWN COUNCIL, FOR THE TOWN OF EXMORE:

SECTION 1. DEFINITIONS

The following words, terms, and phrases, when used in this Ordinance, have the meaning ascribed to them in this section:

DOG: “DOG” shall include both the male and female sex of the canine species and unsexed males and females of said species.

OWNER: “OWNER” Shall include any person who:

- Has a right of property in an animal;
- Keeps or harbors an animal;
- Has an animal in his/her care; or
- Acts as custodian of an animal.

RUNNING AT LARGE and RUN AT LARGE:

A dog walking, roaming, loitering, running, self-hunting or destroying property of others (such as garbage cans, gardens, flowers, shrubs, lawns, etc.) off the premises of its owner or custodian without being caged, physically carried, or held by leash or lead attached to a collar or harness under the control of a responsible person capable of physically restraining the dog.

SECTION 2. REGULATION OF DOGS

(a) It shall be unlawful for the owner of any dog to allow or permit any such animal to run at large with the incorporated limits of the Town of Exmore even though the animal may be lawfully licensed and vaccinated against rabies.

(b) It shall be unlawful for the owner of any dog to allow, cause, or permit such dog to enter any public building, office, or store during the time that such business establishments are open for public business, unless the dog is a seeing eye dog or trained service animal on a leash or lead attached to a collar or harness and under the control of the owner.

(c) (1) Any dog found at large may be confiscated by the County Animal Control Deputy or other authorities and if not claimed within twelve (12) days, it shall be disposed of pursuant to VA Code 3.1-796.96.

(2) In the event that any dog confined pursuant to this section is claimed by its rightful owner, such owner shall be charged with the actual expense incurred in keeping the dog impounded. Before the dog is released, the owner shall execute an affidavit of ownership, present the proper dog license, and pay all the expenses incurred in keeping the dog confined.

SECTION 3. PENALTIES

(a) It shall be the duty of Exmore Police Officers to enforce all provisions of this ordinance.

(b) Any person who violates any provision of this ordinance may be guilty and subject to a civil penalty of \$100.00 per dog so found.

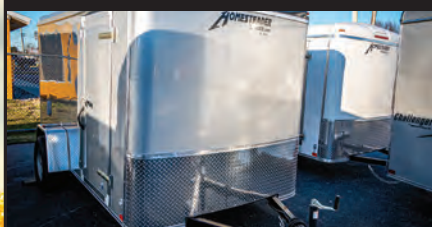

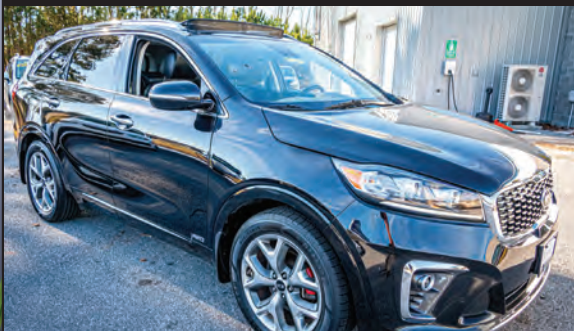
