## The little engine that could

Cape Charles' 1924 fire engine set to return to town's July 4 parade — fingers crossed

For years, every parade in Cape Charles was led by the Cape Charles Volunteer Fire Company's 1924 American LaFrance fire truck, which town firefighters bought brand-new a century ago.

It's spartan and tiny compared to today's colossal fire engines, which gleam with chrome and lights.

But the old truck's motor's water pump went bad a few years back. And it was hard to find a replacement.

"Every time we'd try to run it in the parade, it would run hot and boil over," said Ryan Peake, the fire company's treasurer.

The pump, however, has been replaced. Fire company officials plan on having the centenarian truck back in its usual spot — at the front of the line, right behind the color guard — in the town's Independence Day parade on July 4 at 10 a.m.

"We're crossing our fingers," said Peake, with a nod to the balky nature of 100-year-old vehicles.

A Pennsylvania machinist who specializes in repairing old American LaFrance trucks created a new water pump.

## Supervisors OK rezoning, permit for massive Onley project

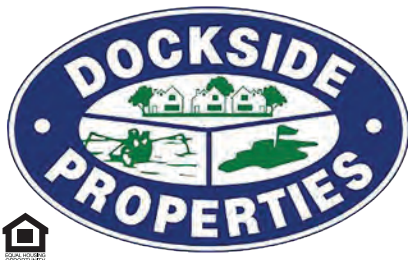
The Accomack County Board of Supervisors voted unanimously June 20 to grant a rezoning request, along with a separate conditional-use permit, for the developer of a massive housing community proposed for an area near Onley and Tasley.

The Accomack County Planning Commission had recommended approval of a conditional rezoning, subject to proffers, after it held public hearings on the matter in March and April.

Owner and developer Chris Carbaugh, of Atlantic Group and Associates Inc., and Coastal Square and Residences LLC, requested a zoning change of 95.89 of approximate 100 acres of land from a business and agricultural district to village development.

Built in several phases, the Coastal

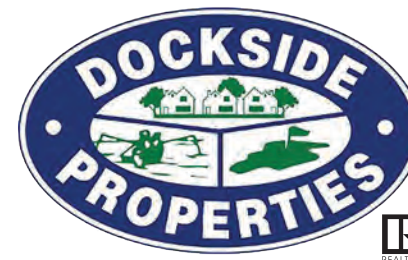

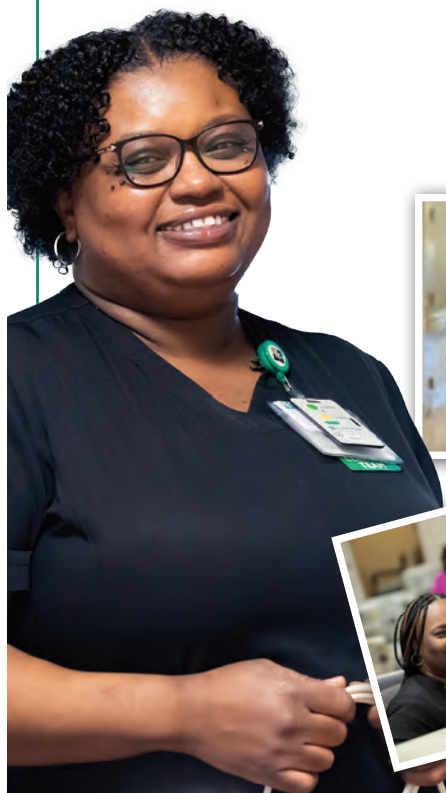

Peake credited many in the fire company, including Chief Jay Bell, President Bill Powell, Deputy Chief Jeb Brady, and Assistant Chief Matt Pruitt, with their dedication to the old engine.

Even at its advanced age, company officials say it last worked a fire alarm

in the 1980s, when it pumped water from the town harbor on a boat fire.

The engine still has its original wood ladders, wooden spoke wheels, and an oil-fired lantern on its side.

After the parade, the engine will be on display at Peach Street Books for the public. The fire company also will be accepting donations at the display.

Peake said the fire company hopes to buy a new fire truck — the town has given the company a \$250,000 matching grant toward its purchase.

The fire company's pumpers and tankers are more than 25 years old — in a growing community that has seen more than 300 homes built in the past five years.

Peake said a new fire truck could cost \$800,000 — so the company has some fundraising ahead of it.

When the money is raised and a new fire engine is eventually purchased, it will share a home with the town's first truck, which is working on its second century in town.

"It's amazing it has stayed intact this long," Peake said.

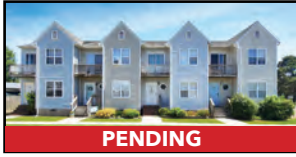

# Supervisors get briefing on state legislation impacts

Northampton County Attorney Michelle Clayton on Tuesday, June 25, apprised supervisors of new state legislation with potential local impacts.

Two of the bills that recently passed the Virginia General Assembly deal with the hot-button issue of short-term vacation rental homes:

House Bill 1461 states that, if a person is leasing or subleasing a property, a locality cannot bar that person from offering the property for short-term rental if the person has the permission of the property owner.

Senate Bill 544 states that a locality can neither require a special- or conditional-use permit for the short-term rental of an accessory dwelling unit nor bar a property owner from offering an accessory dwelling unit for short-term rental if the property owner legally occupies the main home as his or her primary residence.

The General Assembly also passed legislation, House Bill 634 and Senate Bill 308, that prevents a locality from enacting or enforcing an ordinance prohibiting home rental for 30 consecutive days or longer.

A locality may regulate these rentals if the regulations are reasonable and do not exceed the requirements for owner-occupied homes or rental homes with lease terms of 12 months or more.

Clayton reviewed several bills on land use that may have local impact:

House Bill 755 allows a locality, by ordinance, to charge a civil penalty for

a commercial or industrial facility for certain property violations. For example, a retail store could be penalized for allowing a mosquito pond in its parking lot, the county attorney said.

Senate Bill 296 states that local planning commissions must use the same approval processes for residential developments as the planning commissions use for commercial developments.

House Bill 1486 and Senate Bill 48 allow a locality, by ordinance, to require a property owner to register a building that has been vacant for 12 months or longer, meets the definition of “derelict structure” or “criminal blight,” or is occupied by a squatter – a person living in the building without the permission of the property owner.

Furthermore, House Bill 478 and Senate Bill 49 allow a locality to establish a community revitalization fund to prevent neighborhood deterioration. Richmond currently is the only Virginia locality to have such a fund.

Clayton reviewed several bills with environmental impacts, including House Bill 220, which allows sewage treatment facilities to employ licensed operators to monitor the facilities remotely and stay in compliance with state regulations.

She also discussed other bills, including one that prohibits workplaces from discriminating against employees for the lawful use of cannabis oil.

Law enforcement officers are exempt from that protection, which Clayton deemed “not very fair, because they have pretty stressful jobs.”

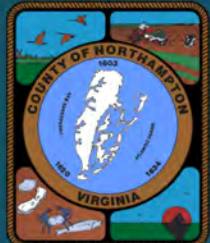

Square development, located near Cooperative Way and the Chesapeake Square shopping center in Onley, will consist of multiple residential and commercial options.

Plans include the construction of 312 garden-style apartment units housed in 13 buildings, 55 townhouses, 76 duplexes, and 22 loft apartments created over commercial spaces.

Carbaugh said 20% of the garden apartments would be designated as “workforce housing” for middle-income individuals, couples, and families who typically don’t qualify for most federal housing assistance programs.

The tree-lined community would include amenities such as basketball and tennis courts, walking trails, a pool with clubhouse, a recreational center, a child care facility, sidewalks, and playgrounds.

Water service would come from the town of Onancock.

“I think we have a good project here,” said Carbaugh, adding that it will help to address the county’s housing shortage, while offering options for residents other than single-family dwellings.

In other news,

■ County Administrator Mike Mason expressed an interest to host a roundtable discussion with local business and industry representatives, to address the need for increased child care options in northern Accomack County, including Chincoteague.

His plans would include involving representatives from the Navy, NASA, private contractors, and space companies, plus larger corporations such as Tyson Foods. Local child care providers would also be an integral part of the discussion.

■ Representatives from the Foodbank of Southeastern Virginia and the Eastern Shore presented statistics showing a sharp rise in the number of food insecure individuals in the county, from 3,230 to 4,340 in one year’s time, an increase of 34%.

They suggested an expansion of the Tasley foodbank facility as a potential solution to serve more people, jump-started through funding from a non-matching \$100,000 Department of Health and Community Development planning grant.

Mike Mason assured the supervisors that DHCD planning grants aren’t part of that department’s funding cap. Therefore, he said, this would not impact the county’s DHCD funding earmarked for derelict housing demolition and renovation projects scheduled in Horn-town.

He suggested that further discussion to develop a non-binding memorandum of understanding (MOU) between the county and the foodbank regarding specifics of the project occur at the next monthly meeting scheduled for July 17.

■ The Board of Supervisors unanimously approved a FY 2025 funding request from the Eastern Shore 911 Commission to increase staff compensation from 1% to 3% to match the compensation of county employees.

## Burn ban instituted in Accomack County

In accordance with the Accomack County Code, Article II, Open Burning, Section 42-49, the county administrator has declared a burn ban due to dry conditions creating a threat to life and property throughout the county.

This suspension of burning applies to and prohibits all open burning within Accomack County’s jurisdiction only. This suspension is effective

immediately and will continue until conditions change.

Campgrounds and agriculture activities are exempt.

Any violation of the Accomack County Open Burning Ordinance is punishable as a Class 1 Misdemeanor, which may result in confinement in jail for not more than 12 months and a fine of not more than \$2,500, either or both.

### Celebrating our farmers during Virginia Ag Week

Gov. Glenn Youngkin proclaimed June 23 to 29 as Virginia Agriculture Week in recognition and celebration of the Commonwealth's agricultural industry.

The Virginia Department of Agriculture and Consumer Services encourages the public to join in supporting the Commonwealth's farmers and local economy by purchasing Virginia grown and produced agricultural goods from the state's diverse offerings.

"Agriculture is Virginia's largest private industry and an economic driver for the state. The industry contributes over \$82 billion to our economy, with more than \$43 billion in value-added impact, and provides over 381,000 jobs throughout the Commonwealth," said Youngkin.

According to the USDA National Statistics Service data, the Commonwealth is home to approximately 39,000 farms that cover 7.3 million acres. Virginia's diverse agricultural production includes livestock, field crops, fruits, vegetables, poultry, dairy, greenhouse and nursery, aquaculture, and vineyards. The Commonwealth ranks third in the nation for seafood landings and leaf tobacco, fifth for apples, sixth for turkeys, eighth for peanuts; and ninth for broilers measured in head and pounds.

Scientific and technological advancements have fueled greater efficiency in agricultural production. Present-day farmers produce enough to feed their family plus the equivalent of 155 people around the world, compared to less than ten people in the 1930s.

"Virginia Agriculture Week is the perfect opportunity to celebrate and support the local family farm businesses at the heart of so many of our communities," said VDACS Commissioner Joseph Guthrie.

Since 1970, LGBTQ+ people have gathered in June to march with pride and demonstrate for equal rights.

Three to five thousand marchers participated in the inaugural PRIDE and today participants number in the millions.

A video from this original event is available in the Library of Congress archives.

The video highlights the atmosphere surrounding the struggle of the LGBTQ+ community to access self-expression and human rights.

PRIDE is an acronym for Personal Rights in Defense and Education.

The video is filled with interviews of the parade participants and the onlookers.

One participant was asked what was the most negative experience that they had faced from the public opinion on homosexuality.

LGBTQ+ youth with a supportive adult or teacher in their lives are 39% less likely to have used alcohol in the past 30 days.

Youth with families that really try to help them are 63% less likely to have misused prescription drugs in the past 30

We also say: "I'd like to give a shout-out to my peeps for helping me get through the tough times."

(We also should stop using the term "peeps" to refer to people dear to us. I am nobody's "peep," but I am friends to many. "Peeps," where I come from, are sugary marshmallow snacks brought by the Easter bunny.)

"Shout-out" is a strange term. It actually sounds like the description of an argument:

"Mama got mad after I told her I was dropping out of college and we had a shout-out in the front yard," someone might say.

Or: "They shorted me a spicy tender at Ro-Fo and I had a shout-out with the cashier, and told him I was about go off if I didn't get more chicken."

(When I was growing up, the term "go off" meant "to leave," as in, "Alfred, our kitty cat, was about

45 years old when he decided to go off and die, and we haven't seen him since.")

These days, "go off" means to lose one's cool and have a tantrum. I don't know why.

Using "shout-out" to express gratitude is akin to using the term "swearing in" or "sworn" to mean "oath of office," which is one of my pet peeves.

"Oath of office" sounds dignified, almost regal. Judges, politicians, and the like take an oath of office, I always argue. They aren't sworn in.

"Swearing in" or "sworn in" sounds like what you do, in a fit of rage, to a lawn mower that won't start.

These days, however, when thanking the people who fixed your lawn mower, you'd give them a shout-out:

"I'd like to give a shout-out to the guys at the shop who fixed my broken mower after the swearing-in I gave the darned thing."

Why do we have this affinity with unnecessarily injecting the words "shout" and "swear" into our everyday vernacular?

I think the attraction to the term "shout-out" comes from the general reluctance of people to say "thank you," which are the most important two words in the English language.

Maybe expressing sincere gratitude by saying "thank you" appears weak or subordinate.

Perhaps using the term "shout-out" sounds more chic and contemporary, two characteristics that have never much concerned me.

So the next time you want to publicize or vocalize your appreciation, just say "thank you."

It sounds more sincere than a shout-out. And sincerity should always be a goal of ours.

days and are 37% less likely to have used illicit drugs in the past 30 days.

Creating safe spaces is a pivotal protective factor for any form of community. Safe spaces involve learning the facts, using inclusive language, and finding collaborative resources.

Even an individual can be a safe space through understanding and kindness.

Learning the facts could be as simple as having an open-minded approach to learning about the experiences of those within the LGTBQ+ community.

Using inclusive language could be saying "Hello everyone," instead of saying, "Hello boys and girls."

Inclusive language could also refer to the use of identifying pronouns (she/her, he/him, they/them).

This slight change opens the door for the individual to state how they view themselves.

PFLAG is the nation's largest organization dedicated to supporting and educating LGBTQ+ people and their loved ones.

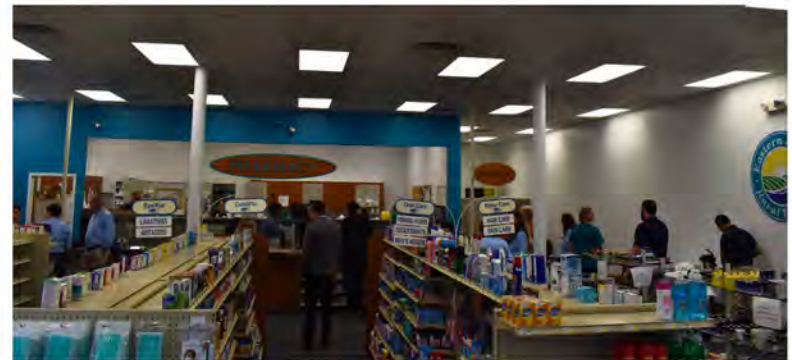

# Temperanceville woman jailed for smuggling drugs to inmate

A Temperanceville woman will spend three months in jail for delivering an illegal drug to an inmate in the Accomack County Jail.

Last October, an informant told authorities that a controlled substance could be found on a female prisoner.

A search revealed buprenorphine, a synthetic opioid used to treat pain and opioid use disorders.

Mychael Lezelle Jones, 28, “has no significant criminal record,” said Commonwealth’s Attorney Spencer Morgan.

He said he entered into a plea agreement with Jones.

In exchange for her plea of guilty to one felony, he agreed not to prosecute

the second felony charge of conspiracy to deliver a controlled substance to an inmate.

That charge resulted from authorities listening to recordings of jail phone calls as Jones and inmate Amanda Daisey planned their scheme to get the drugs to her.

Morgan told the court that the drug was taken to Daisey inside the lining of an eyeglasses case.

“Jones has children. She didn’t get paid for this; she was a friend of the inmate,” said defense attorney Garrett Dunham.

Judge W. Revell Lewis III accepted the agreement and sentenced Jones to five years with all but three months suspended. Jones will be on supervised probation for three years, which will begin upon her release.

# Neal lands 260-pound bigeye tuna

The official start of summer, at least according to the calendar, ushered in temperatures more associated with late August than mid-June. These hotter-than-average air temperatures have raised local

bay and inshore seaside surface water temperatures, causing concern among some local anglers that typical springtime fisheries may be short-lived.

On the bright side, the warmer waters will fall into the comfort zone of the typical summertime species such as Spanish mackerel, cobia, and sheepshead. The warmer offshore water temperatures should jump-start the offshore blue water fishery with arriving tuna, dolphin (mahimahi), wahoo, and blue and white marlin.

## Upper Shore

Captain Matt Abell, at the Sea Hawk Sports Center, reported that Pocomoke and Tangier sounds continue to provide catches of speckled trout and red drum in the shallow grassy areas. Chunks of peeler and soft crab continue to be the bait of choice when they can be found. Red drum have ranged from puppy-sized all the way up to trophy-sized release citation qualifiers.

Schools of medium- to larger-sized bluefish are still being encountered in the Chesapeake Bay. The best chance of locating these predatory game fish is to concentrate over and around deeper water structures, especially rock piles and submerged vessels. While bluefish can be found patrolling the waters above the structures,

sheepshead have started taking residence inside and along these same fish-attracting artificial reefs. Cobia catches continue to be made from the mid-bay down to the Chesapeake Bay Bridge-Tunnel.

## Chincoteague

Flounder action has been sporadic inside the inlets, with one captain telling me that clients are catching as many as nine throwbacks for every fish that meets the 17.5-inch minimum size limit. Anglers willing to put in the time are managing to boat a few flounder to 20 inches for their effort. The best action continues to be on a two-hook top and bottom rig, baited with Berkley Gulp and a live minnow or silverside, and fished from the hour before through the hour after high tide.

Kingfish (whiting) have been a welcome bycatch inside Chincoteague Bay. Spot and small croaker catches have come from inside of Chincoteague Inlet.

Though not as plentiful as inside the inlet, a larger class of flounder are starting to bite on the inshore ocean wrecks for anglers jigging large bucktails baited with larger Gulps or strip baits. These same wrecks are holding increasing numbers of gray triggerfish, sheepshead, and Atlantic spadefish.

Yellowfin tuna and a few bigeye tuna are starting to hit trolled ballyhoo in the blue waters of the canyons, while deep droppers continue to do well with blue-lined tilefish.

Jimmy Vasiliou, at Captain Steve's Bait and Tackle, told me that fishing in the surf "has been great lately," especially with kingfish (whiting), with anglers, at times, reporting strikes on almost every cast.

## Wachapreague

Captain Lindsay Paul, aboard the Almost Persuaded, told me that flounder continue to be caught when clear water can be found. He said that keeper-sized fish have been caught around the changes of the tides, with Gulp and live minnows or silversides being the productive bait presentation.

Black sea bass continue to be caught on the offshore wrecks. Captain Paul said that Captain Keith Neal, aboard the Teaser, landed a 260-pound bigeye tuna and Wayne Evans released a white marlin and landed a tuna aboard the White Bite.

## Lower Shore

Jeb Brady, at Bailey's Bait & Tackle, told me that the lower bay cobia fishery is still capturing the attention of almost all of the local anglers. Bottom fishing for cobia was described as "slow" over the last week, although a few nice-sized fish are still being landed. Sight-fishing for cobia was said to be more eventful, with anglers spotting lots of fish cruising the surface waters.

Brady reported that anglers using chunks of crab have boated some large sheepshead from around the pilings of the bridge-tunnel. Spadefish catches on clam baits have come from the waters around the fourth island of the bridge-tunnel.

The flounder fishery remains steady inside the Ditch and around the Fisherman Island bridge, with squid and Gulp combinations being one of the most productive bait presentations.

Tasty kingfish (whiting) are showing up in large numbers around the Kiptopeke concrete ships and are being caught with pieces of clam fished on the bottom.

Large schools of bluefish have been cruising up and down the lower bayside shorelines. Anglers tossing topwater lures into the schools have been rewarded with blues measuring up to 30 inches. Small trout and croaker catches have come from the Kiptopeke State Park and Cape Charles piers.

# Shore breezes through District 8

## Azalea vs. Shore

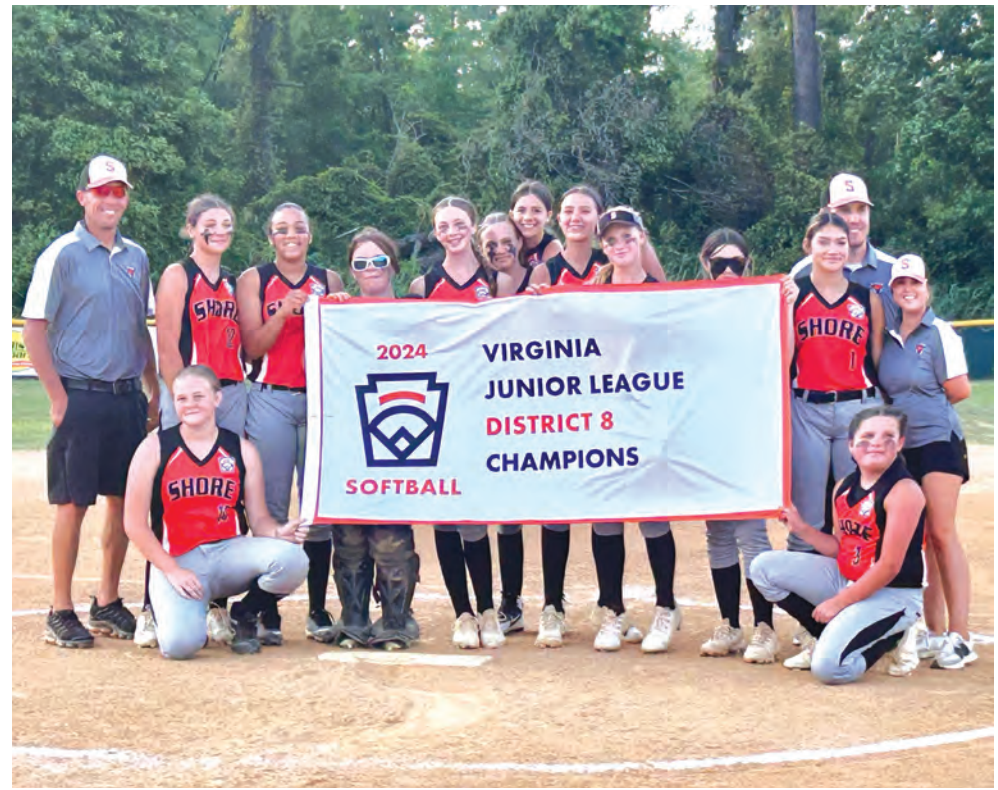

# In Cape Charles, 11 vie for three town council seats

A crowded field of 11 residents have filed to run for three town council seats in Cape Charles, the polished beachfront vacation spot riven by the issue of short-term rentals and their impacts on the town.

Two of the three current council members whose terms end Dec. 31 did not file for re-election to the six-member council.

Councilman Andy Buchholz is the only incumbent who filed for the Nov. 5 town election. The filing deadline was June 18.

Also running for council are Edward Wells, Malcolm Hayward, Mark Usry, John Rowe, Carol Sabo, Martin Beckett, Clayton Newman, Tara Ashworth, Jo Bronson, and Courtney Fraas.

Vice Mayor Steve Bennett and Councilman Andrew Follmer are not seeking reelection. Cape Charles' mayoral seat and three other council seats are not up for election this year.

The town has been divided in opinion over vacation rentals, which detractors say take a disproportionately large number of parking spaces, create late-night noise, and erode the town's neighborly vibe.

Proponents say short-term rentals are the lynchpin to the town's business successes and have led to the continued renovation of blighted homes.

## Cheriton

In Cheriton, former town clerk Stacey A. Sparrow is running for mayor against Larry LeMond, the current mayor.

In addition, there are eight candidates running for six town council seats: Ivan Pena (incumbent), Kandy Pena, Robert K. "Bo" Lewis (incumbent), Terri Lynn Tatem, B.B. "Barry" Downing Jr. (incumbent), Sheila M. Traina, Jason B. Sparrow (incumbent), and Norma Spencer (incumbent).

Council member Greg Hardesty did not file for the election.

## Eastville

In Eastville, incumbent Mayor James C. Sturgis is running unopposed, but eight candidates are seeking six town council seats.

Town council candidates include Eleanor Gordon (incumbent), Diane Crockett, John Crockett, Allen Philpot (incumbent), Barbara Thomas (incumbent), Bonny Lewis, Leslie

Shiflett, and Anne Sayers (incumbent).

Council members not running for re-election are Mary Beth Briggs and Douglas Coburn.

## Nassawadox

In Nassawadox, incumbent Mayor Patricia Stith is running unopposed. Only three candidates filed for six council seats: John Hallett Sr., Thomas Wilson Rippon, and Andrea Fox.

## Exmore

In Exmore, incumbents Thomas Lewis, Chase Sturgis, and John C. "Coby" Metz all filed for re-election. Claudia Andrews is the lone candidate for a vacant council seat.

# Supervisors raise taxes a nickel, give schools \$2.3M hike in local money

Northampton supervisors have approved the county's fiscal year 2025 budget and set new tax rates that will help pay for more than \$23.6 million in general fund expenditures.

"This is going to be the lowest tax rate since 2016," said Supervisor Ernest Smith on Tuesday, June 25.

He was speaking of Northampton's new real estate tax rate, which is effective for the current year and will be used to calculate the tax bills that homeowners receive in December.

The rate was reduced from 76 cents to 68.5 cents per \$100 of assessed value, which will help offset the higher tax bills that many will pay due to rising property values.

The real estate tax rate was reduced by about 10%, but property values increased an average of around 20%, meaning many homeowners will still pay higher taxes than they did last year.

In accordance with Virginia Code, the county had calculated an equalized tax rate of 63.35 cents per \$100 — the rate that would produce real estate tax revenue equal to the amount Northampton received last year, plus an additional 1%.

However, supervisors declined to adopt the equalized rate and opted for a rate of 68.5 cents, about five cents higher, to fund the county's bulging budget. That decision also was permitted by state law.

Supervisor Oliver Bennett stood alone in opposing the effective tax increase.

"I ask myself the question, 'Are we good stewards of citizens' money?' It's not my money," he said.

Bennett questioned whether all

of the items in the budget were truly needed and warranted raising taxes.

Northampton will receive about \$2.9 million more in real estate tax revenue this year, a total of nearly \$21.3 million. The county generated about \$18.4 million in real estate tax revenue last year.

"When I raise taxes, I say, 'Am I hurting those folks that I'm trying to help?'" Bennett said.

Much of the additional tax revenue will support Northampton County Public Schools.

Last year, the county's contribution to the cost of running the school system was nearly \$10.5 million.

This year, the schools will receive about \$12.8 million in local funding — an increase of around \$2.3 million.

At least \$1 million of that additional funding was needed because a state calculation called the local composite index determined that Northampton can afford to pay more of the cost of its public education.

The local composite index is based 50% on real property values, so a county with a high percentage of low-income families won't necessarily benefit.

Smith supported the new tax rate but suggested Northampton should do more to draw attention to its tax relief program for the elderly and disabled.

A taxpayer with an annual household income of no more than \$50,000 can receive up to \$1,000 in tax relief per year.

Deputy County Administrator Janice Williams said that every Northampton real estate tax bill provides notice of the tax relief program and directs the taxpayer to the county website for more information.

Supervisors noted that some elderly residents don't see the notices on

their tax bills or use the internet.

Smith said many residents complained because they did not become aware of the program until after the application deadline had passed.

He also suggested raising the program's income limit.

But "I don't want schools cut. I don't want anything ... that we need to be cut," Smith said.

Supervisor John Coker noted that, over the last two years, the rate of inflation was about 12%, "and this budget is not near that kind of increase."

"This is not a big increase," Coker said, "and it's an increase I think we need to make."

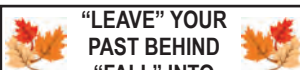

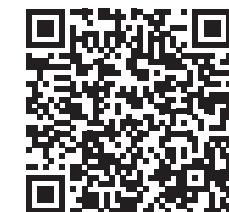
